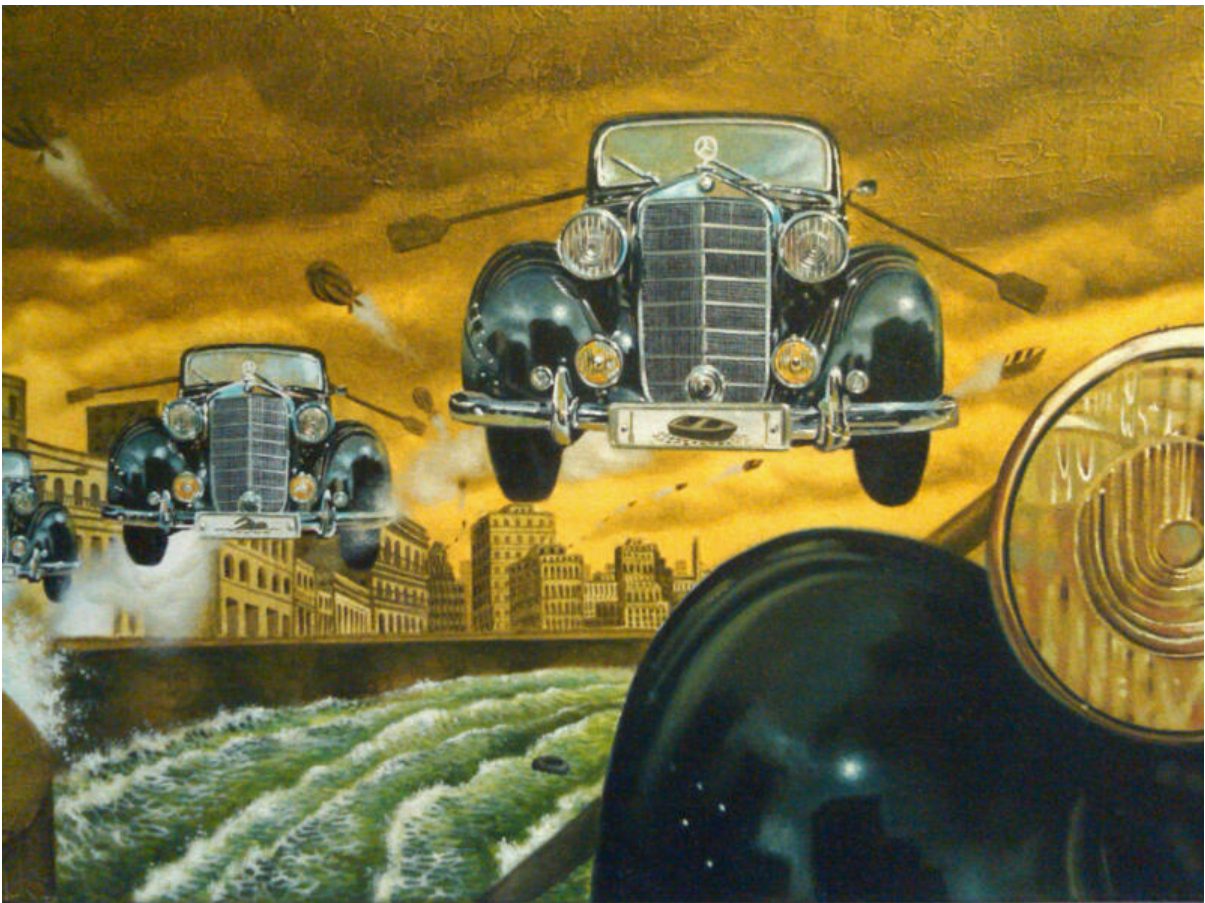

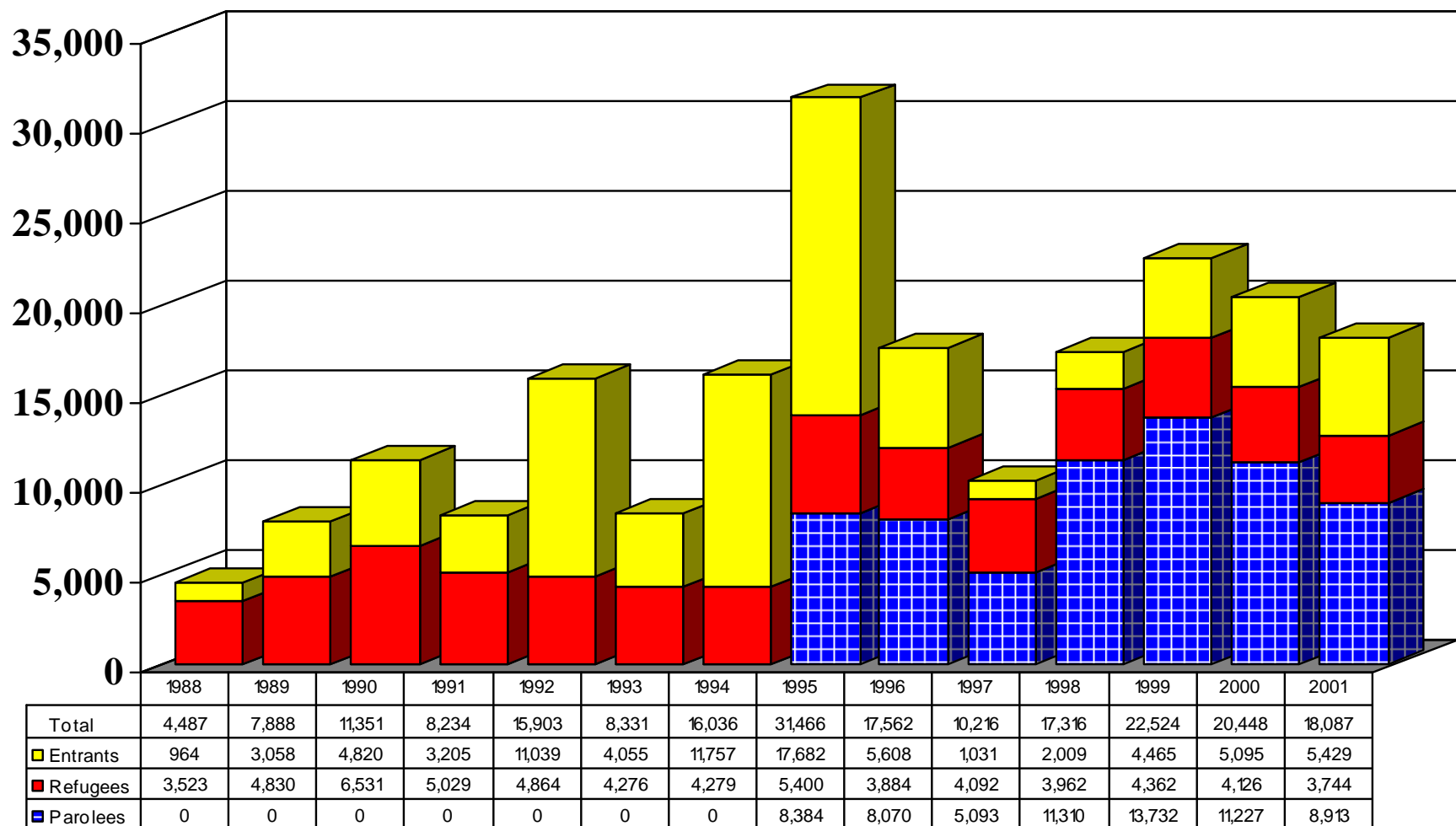

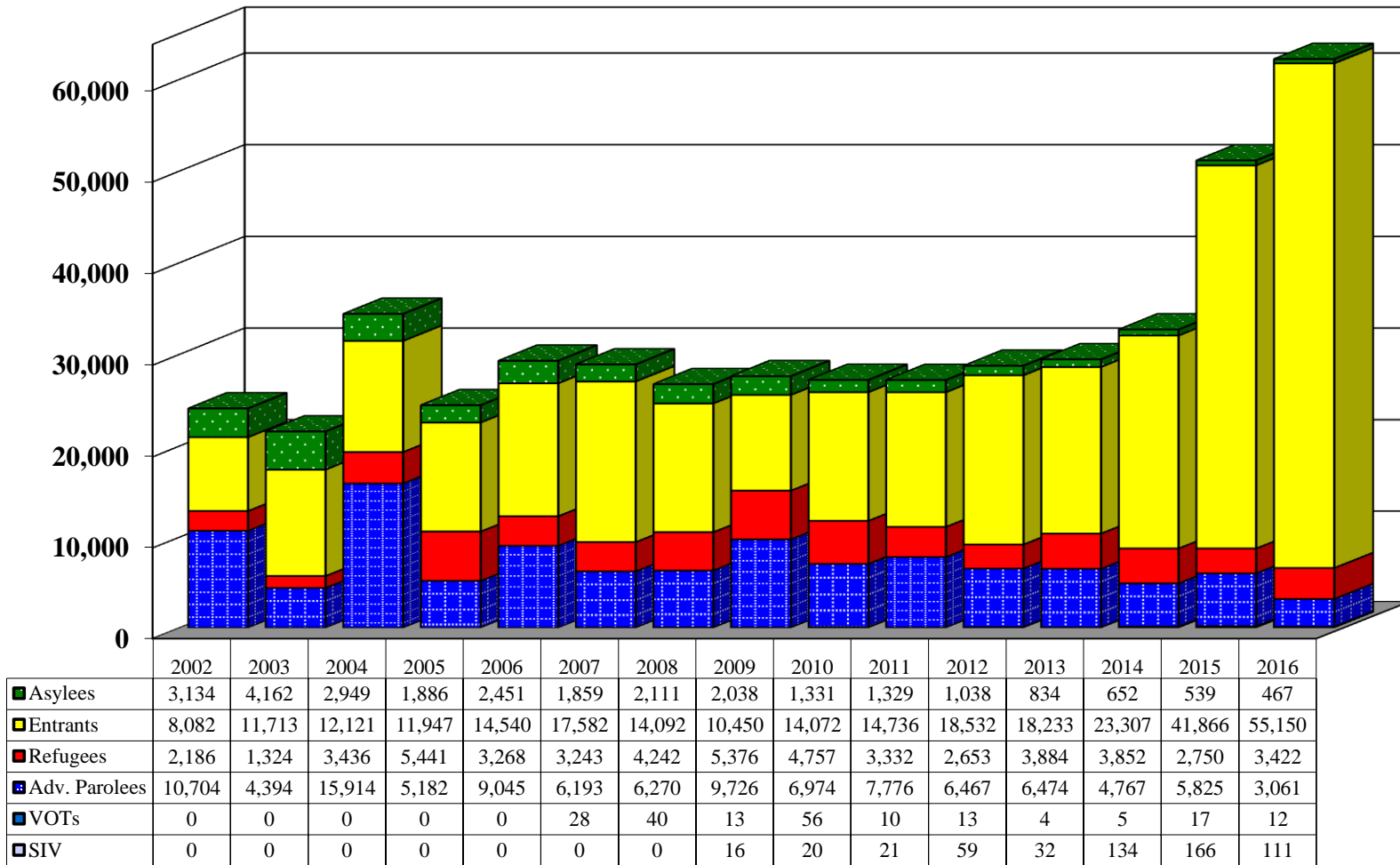
State of Florida Arrivals Federal Fiscal Years 1988-2001 by Status
