## New Analytic Unit Process for the city police departments in South Brevard:

- -Requests for police reports that are noted in the reporter information will be made automatically at 4:00 on the day the case comes into triage.
- -Requests for address checks that are listed on the report will be made automatically at 4:00 on the day the case comes into triage.
- -These requests will be sent in one large batch to the Police department on an excel spreadsheet which the support staff will keep updated on the shared drive
- -If you have updated information such as a new address or police report needed please email it to Tanya Russell and Tina Galli by 4:00 and they will add it to the spreadsheet request
- -The police departments prefer requests from one single point of contact, however if you are working evenings/ weekends and you need the report/ address check in a **rush**, you may still email the Police department directly: but please cc: Tanya & Tina. If it is not an urgent request, and can wait to be added to the spreadsheet, please just email Tanya & Tina and your request will be added to the spreadsheet during normal business hours

Any information that indicates there is an active clerk of court record in the Reporter information will be automatically requested on the CPI's behalf on a daily basis (if necessary) at 4:00.
