If all medications have consent properly documented and all such consents are Court Order Obtained, the child is counted in the Court Order counts. Proper documentation includes either Parental Consent or Court Order Obtained and the date such consent was obtained both being documented in FSFN. Any consent dates that are after the run date of the report or which are entered after the report run date are not considered valid for these puproses. The Consent tab includes the counts and percentages for all children with a prescribed medication as well as a separate set of counts and percentages for only those children for whom parental rights have been terminated. |
