

Psychotropic Medications Report

This report includes all children (age 0 to 17) who are active in an Out-of-Home Care placement as of 4/25/2012.

The medications data in this report is based on children documented in Florida Safe Families Network (FSFN) as having an active prescription for one or more of the medications listed below, or an "Other" medication that is documented as having been prescribed for psychotropic purposes within an active Out-of-Home Care case. The medications listed below are the specific psychotropic medications listed The list in FSFN should not be interpreted as an all inclusive list of psychotropic medications. The Department is pursuing changes to the FSFN system that would expand this medication listing.

A child is only counted once in the Meds column regardless of the number of such prescriptions (i.e., it is an unduplicated count of children NOT medications).

If a child has one or more medications currently prescribed for which consent has not been properly documented in Florida Safe Families Network, the child is counted in the No Consent Obtained counts. If all medications have proper consent and one or more is Parental Consent, then the child is counted in the Parental Consent counts. If all medications have proper consent and all consents are through Court Order, then the child is counted in the Court Order counts. Proper documentation includes either Parental Consent or Court Order Obtained and the date such consent was obtained both being documented in FSFN. Any consent dates that are after the run date of the report are not considered valid for these purposes.

There are a limited number of instances when psychotropic medications can be administered to children in custody of the department prior to obtaining express and informed consent. These may occur at initial removal from the home, at any time a physician certifies in the medical report that delays in adminstering the medication would more likely than not cause significant harm to the child, and when the child is being treated in a hospital, crisis stabilization unit, or statewide inpatient psychiatric program.

Note: Age is as of 4/25/2012 and is calculated based on date of birth.  
Race is determined as follows: If a child's only race selected in FSFN is black, then the child is considered black; if the child's only race selected in FSFN is white, then the child is considered white; all other races or children with more than one race selected in FSFN are considered other.

Placement Setting Description:  
Relative/Non-relative Care: Children removed from their homes and placed with relatives or family friends.  
Licensed Substitute Care: Children in licensed foster homes, group homes and residential treatment facilities.  
Other: Children on runaway, absconded or abducted; in a hospital; DJJ placement; Agency for Persons with Disabilities placement, Substance Abuse placement, etc  
Placement Data Not Available: Children who are in the process of changing placements or whose placement data has not yet been updated or entered in FSFN.  
Note: As of August 10, 2009, FSFN's Release 2b modified the placement settings and they no longer completely comparable to prior reports.  
This change does not impact the totals (for out-of-home care or medications), only the distribution across placement settings.

The data presented here are drawn from Florida Safe Families Network (FSFN), which includes case information submitted by the Department's Community Based Care partners. The Department is in the process of refining its policies, practices and data systems as they relate to the provision and documentation of psychotropic medications for children in out-of-home care. As part of this effort, the Department is currently assessing the reliability and validity of the data contained in FSFN with respect to psychotropic medications. Where indicated during this Quality Assurance process, the Department and its CBC partners are taking action to correct such data, particularly that related to informed parental consent. Until this process is complete, the information in this report should not be considered final.
