## BROWARD COUNTY REFUGEE TASK FORCE MEETING

### **INTRODUCTION**

The meeting was held via a conference call and Miriam Rosario, Southeast Region (SER) Community Liaison (CL), Refugee Services (RS) Program, Florida Department of Children and Families (DCF) facilitated the Refugee Task Force (RTF) meeting. Miriam thanked and welcomed all participants. The meeting was called to order and participants introduced themselves, services and the agency they represented. Approximately 40 people joined the meeting.

### **SPECIAL PRESENTATIONS**

**Jeffrey Hittleman, Staff Attorney in the Senior Citizen Law Project at Coast to Coast Legal Aid** of Broward County, provided an overview presentation about housing issues during COVID-19 and the resources available through Coast to Coast Legal Aid. Legal Aid of Broward County is available to help with these housing questions and resources. Services can be offered in various languages. The phone numbers to call Legal Aid in Broward are 954-765-8955, 954-736-2496 and 954-736-2497.

**Melissa Jaramillo, Manager, Community Outreach, Step Up For Students**, provided a power point presentation regarding Step Up For Students and the scholarships still available. Step Up for Students administers five scholarship programs for Florida's schoolchildren:

- The Florida Tax Credit and Family Empowerment Scholarship for children K-12 from lower-income families.
- The Gardiner Scholarship for children ages 3-22 who have certain special needs.
- The Hope Scholarship for children K-12 who are victims of bullying.
- The Reading Scholarship Accounts for public school students in grades three through five who struggle with reading. Apply Now. ### **GENERAL UPDATES/ANNOUNCEMENTS:**

Each agency discussed how services were being provided during the pandemic and plans to reopen offices. Palm Beach County remains under a Continuing State of Emergency. A reminder was given to enroll in the 2021 Health Marketplace by December

**USCIS**, Berta Cassidy, Community Relations Officer (CRO), Miami and Caribbean District U.S. Citizenship and Immigration Services, participated. She stated that USCIS asylum offices will automatically reschedule asylum interviews that were canceled during the temporary closures. Also, USCIS announced plans to implement a revised version of the naturalization civics test. Applicants who apply for naturalization on or after December 1st, 2020, will take the updated version of the test. Those who apply before December 1st, 2020, will take the current version of the test.

**Broward County Library (BCL)** - Vonda Ward Bryant, Broward County Library reported on all the resources available thru the Broward County Library. The Broward County Library offers citizenship classes and English Basics classes online.

**American Red Cross (ARC)**, Jaime Cruz, Service to the Armed Forces & International Services Specialist stated all local ARCs are closed. ARC is also offering support and resources for Fire prevention and victim of fires in Broward County. If anyone has questions, they can call (M): 786-714-6796.

**Agency for Health Care Administration (AHCHA)** -Jerome Hill – Program Operations Administrator, - Bureau of Medicaid, informed the task force that their office is closed and AHCA continues to work virtually. However, all services are still being offered. Jerome.Hill@ahca.myflorida.com

**Broward County Family Success Center/ Community Action Agency (FSC/CAA)**- Audrey Ljung, Community Coordinator, reported on Broward County Housing assistance resources. **ESS/DCF**- Wilber Roney; introduced Claudia Arce to the Refugee Task Force. She is helping with the ACCESS benefits applications. DCF's Statewide Customer Call Center is also available for customer questions and application assistance at 850-300-4323 (TTY 1-800-955-8771), Monday through Friday, 7 a.m. to 6 p.m.

**RS/DCF** – David Draper, Community Liaison Manager thanked everyone for being there. He encouraged task force members to visit the DCF website for resources on COVID-19. David gave updates on the presidential determination on refugees (15,000 for this FFY). He also stated that the CDC eviction moratorium is still in place, however he encouraged agencies to continue assisting refugees with housing so that it wouldn't become a bigger issue when the moratorium ends.

**RS Contracted providers: Comprehensive Refugee Services (CRS):**

**Project RENEW /Broward College (PR/BC)-** Jocelyne Martinez, Director, indicated that Adult Education (AE) class sessions are currently online. Adult Education currently has 158 enrollments. The students have also learned computer skills. PR/BC is assessing options for the coming semesters (whether to offer in-person, online, or hybrid classes). PR/BC is also providing laptops to students that need them.

**Church World Service (CWS),** Oscar Rivera, Director Southern Programs, provided information on the Comprehensive Refugee Services (CRS) and Match Grant (MG) programs in Broward. CRS and MG are fully operational, and clients are being seen by appointment only. Virtual appointments are also available. CWS also offers referrals to community resources and assistance with benefits. Oscar stated that Cuban and Haitian arrivals are increasing. CRS is assisting them with employment, childcare, mentoring services and CRS and offering many other referrals in the community. CWS/Broward telephone number is 954-689-6466.

**St. Thomas Human Right Institute (STHRI),** Cristine Reis, Director Attorney, stated that offices are open (via appointment) to assist with all legal matters. USCIS changes and delays are impacting families. These issues have been shared with USCIS representatives. STHRI can be reached at 866.491.6737.
