PALM BEACH AREA REFUGEE TASK FORCE MEETING

INTRODUCTION

The meeting was held via a conference call and Miriam Rosario, Southeast Region (SER) Community Liaison (CL), Refugee Services (RS) Program, Florida Department of Children and Families (DCF) facilitated the Refugee Task Force (RTF) meeting. Miriam thanked and welcomed all participants for calling in and joining the meeting. The meeting was called to order and participants introduced themselves, services and the agency they represented. Approximately 40 people called and joined in the call.

SPECIAL PRESENTATIONS

Gulf Coast Jewish Family & Community Services- Sabine Balmir-Derenoncourt, Program Coordinator, Florida Center for Survivors of Torture provided a presentation on the Survivors of Torture program. Gerald “Jerry” T. Roden, ESQ., Staff Attorney, Legal Aid Society of Palm Beach County, Inc.(LAPBC), in the Rapid Response Eviction Assistance Housing Program, provided an overview presentation about housing issues during COVID-19 and the resources available with the Legal Aid of PBC. On September 1st, the Centers for Disease Control (C.D.C) announced a national eviction moratorium for virtually all tenants in the U.S impacted by the COVID-19 pandemic. The order will be in effect from September 4, 2020 through December 31, 2020. Legal Aid of PBC is available to help with these housing questions and resources. As requested by the members the “Eviction Moratorium” power point presentation was distributed to the RTF members’. The landlords can contact their program as well. LAPBC can assist with keeping the tenant to prevent the additional spread of COVID-19 in their residence and negotiating a deal to pay the back rent owed to the landlord. GENERAL UPDATES/ANNOUNCEMENTS:

Agencies discussed how they are providing services during the pandemic and plans for reopening offices. Palm Beach County remains under a Continuing State of Emergency. Miriam indicated that PBC School (PBCS) continue with all new security protocols. A reminder was given on the deadline to enroll in 2021 Marketplace Coverage (December 15). Clients can also visit “Find Local Help” for a full list of agents and brokers and other assistance in the area by contacting the HealthCare.gov Team.

USCIS, Don Jarrell, Community Relations Officer (CRO), Tampa District U.S. Citizenship and Immigration Services, participated. Don stated that USCIS asylum offices will automatically reschedule asylum interviews that were canceled during the temporary office closures. Also, USCIS announced plans to implement a revised version of the naturalization civics test. Applicants who apply for naturalization on or after December 1st, 2020, will take the updated version of the test. She is helping with the latest regarding ACCESS benefits applications. **Gus Artau**, Florida Dept. of Children & Families, Community Partner Liaison also provided updates on the ESS/DCF benefits.

RS/DCF – Ileana Bustelo, Deputy Director RS, thanked all for being here. She encouraged all to visit the DCF web site for resources on COVID-19. Ileana offered updates regarding RS and on the Presidential Memorandum on refugee arrivals. The CDC eviction moratorium is still in effect, however she encouraged agencies to find ways to assist refugees before it ends. Updates can be found here: www.myflfamilies.com/COVID19.

RS Providers:

Comprehensive Refugee Services (CRS): Church World Service (CWS), David Claros, Supervising Attorney, provided information on the Comprehensive Refugee Services (CRS) and Match Grant (MG) in Palm Beach. CRS and MG are fully operational, and clients are being seen by appointment only. Virtual appointments are also available and referrals to community resources and assistance for any benefits. He stated that the number of arrivals is increasing, especially with the Cubans & Haitians. CRS is assisting them with employment, childcare, mentoring services and CRS and many other referrals in the community. Legal Services are open with appointment to assist with all legal matters. USCIS changes and delays are impacting families. These issues have been shared with USCIS representatives. CWS can be reached at 561-266-0624. **Youth Co-Op, Inc.** Sindy De Leon, Programs Supervisor reported that their office is now open every day and all CDC guidelines are enforced. Clients are being seen by appointment, but walk-ins are not rejected. **Career Sources of Palm Beach County**, Marta Roque, Senior Career Consultant, TANF, reported on the services available to refugee families and the TANF benefits. She discussed the TANF refugee program. Their collaboration and their partnership with Youth COOP. **Catholic Charities, Dioceses of PBC (CCDPBC)**, Sandra Perez, Program Administrator, informed the task force of the services they are providing. The CCDPBC continue with all services, Employment/Match Grant, serving Cuban & Haitian, and Special Grant for Human Trafficking. FFY2021 project numbers based on the enrollment include 30 slots.
