**INTRODUCTION:**

Lourdes Leconte, DCF Refugee Services Community Liaison for the Southern Region welcomed everyone and called the meeting to order. Patti Grogan, Refugee Service Director, provided a brief update on the Program.

**PRESENTATION:**

Dasiely Cruz, Program Director for the Refugee Childcare Microenterprise Development Program in Miami Dade (R.C.C.D.P) Provided an overview of her program to the taskforce members. This program is run by the Children’s Forum. The Forum has a long history of serving vulnerable populations in the child care field through training, advising, mentorship, and coaching. It manages the Quality Counts Career Center in Miami which serves a diverse population of family- and center-based child care practitioners through the Quality Counts initiative funded by the Children’s Trust and Early Learning Coalition (ELC) of Miami-Dade/Monroe. For the Micro Enterprise project, the Forum leveraged its existing partnerships with agencies and institutions that serve and train the early child care community in Miami-Dade County. It has been able to partner with local, county, and state entities that serve refugees. She is seeking to broaden that partnership with other entities at the taskforce to be able to reach a wider range of eligible refugees interested in the child care field and who would like to own their own business in that field The ultimate goal is Assist refugees in becoming economically self-sufficient and help refugee communities in developing employment and capital resources. The program has a five prongs approach to help refugees become successful child care provider’s They provide help, (Financial and educational via a grant funding), ongoing support through mentoring, advice, guidance and assistance.

Sandra Wells, LEP Navigator, Florida covering Kids & Families of the University of South Florida, College of Public Health provided an overview of the ACA program with eligibility guidelines.

**Refugee Services:**

Patti Grogan, State Refugee Coordinator, provided update on the refugee world, she stated there is a visually dramatic drop in arrival numbers. Discussions on how to best manage programs in this uncertain environment. Pending budget approval at the federal level, also plays a role, and currently operating without much information. Some suggestions in how to best utilize future funding:

- Employment programs being enhanced to serve returning/past clients, who have not been in the country more than 5 years.

- Educational programs targeting ESL clients who have not been in the country more than 5 years.
- Legal services programs shifting to complete more LPRs, instead of EADs

Notification received from 11 of the 25 resettlement affiliates in Florida of closures by the end of Sept. 30<sup>th</sup> (current fiscal year).

Key is to try to maintain a network, but the scope of what it will look like, is hard to gauge. Rising housing cost issues continue to be a large barrier, most notably in the Miami and Orlando areas. The economies are much harder to navigate for low-income families.

**Department of Health-RHAP:**

Duncan Sosa provided updated numbers on clients served. As of January, they have served 191 people, mostly Cubans, for new screenings. They are providing follow up services to existing clients, roughly 1400.

Health screening hours have gone back to Mon-Fri, from 7:30a-4pm.

**Community Medical Group:**

Silvia Lopez, Director of Social Services, informed attendees of slowdown of new applications submitted in January. They completed 90 applications for the month. In comparison, to same time in 2017, where 1231 applications completed.

Services have gradually shifted to Medicaid/Medicare recipients. Expansion to the Tampa area continues and actively hiring for openings in March 2018. CMS also planning on expansion into other parts of the country.

CWS, clarified that the POP program has not been shut down, but it has new guidelines/restrictions. There continues to be services available for Cuban Medical parolees, along with clients who have been paroled with humanitarian visas.

- No one in Removal proceedings is allowed to participate
- For people with removal proceedings, they need to prove severe hardship or medical reason. They are being approved on a case by case basis.

**Updates from Refugee Coordinator-Havana:**

The US Embassy continues to be non-operational with minimum staff presence. Awaiting Mid-March decision from State Department, whether personnel will be sent to Havana, or be reassigned.

For refugee cases, applications are still being accepted at the drop box in the consular section. Currently not being processed.

Immigrant visas are being processed out of Bogota, Colombia. Awaiting information on CFRP applicants traveling to Bogota for interviews. There is a real concern due to cost and length of stay.

The Immigration Subcommittee Meeting was held on February 7, 2018 at the Offices of the American for Immigrant Justice (AIJ). Berta Cassidy provided the USCIS updates and Amanda St. Jean provided the EOIR updates, follow up by questions.

Berta Cassidy introduced Kendall Field Office Director, Kristian Parker, and Community Relations Director, Zulma Ruiz, both were present at our meeting on February 7<sup>th</sup>.

**TEMPORARY PROTECTED STATUS (TPS):** USCIS provided TPS updates/handouts for the following countries: Nicaragua, Honduras, Haiti, and El Salvador.

NICARAGUA TPS terminates on January 5, 2019. Individuals who already have TPS have a re-registration period from Dec. 15, 2017 through February 13, 2018. EADs are automatically

extended through March 6, 2018. In addition, the work permit of TPS beneficiaries who timely re-register and apply for work permit will be automatically extended until July 4, 2018

HONDURAS TPS extended through July 5, 2018. Individuals who already have TPS have a re-registration period from Dec. 15, 2017 through Feb. 13, 2018. Their work permit is auto-extended until July 4, 2018.

HAITI TPS terminates on July 22, 2019. Those individuals who already have TPS have a re-registration period from Jan. 18, 2018 through March 19, 2018. Their work permit is auto-extended until July 21, 2018. Individuals who had a Form I-821 and/or Form I-765 pending as of Jan 18, 2018, do not need to file a new application or applications. If TPS is approved, they will be granted TPS through 7/22/2019. If they had a pending TPS-related application for an EAD that is approved, it will be valid through the same date.

EL SALVADOR TPS terminates on September 9, 2019. Individuals who already have TPS have a re-registration period from Jan. 18, 2018 through March 19, 2018. Their work permit is auto-extended through September 5, 2018. Individuals who had a Form I-821 and/or Form I-765 that was still pending as of January 18, 2018, do not need to file either application again. If the pending TPS application is approved, they will be granted TPS through September 9, 2019. If they had a pending TPS-related application for an EAD that is approved, it will be valid through the same date.

**MATTER OF VASQUEZ:** which held that Cuban Consular certificates were accepted to prove Cuban citizenship, has been rescinded. Cubans must have a valid Cuban passport or a Cuban civil registry document issued in Havana.

**US Embassy in Havana:** Department of State has designated the US Embassy in Bogota to process Immigrant Visas in Bogota, Colombia. USCIS services such as I-130s or I-730s will be processed in Mexico City.

**USCIS FORMS:** USCIS will accept applications without the bar-code that appears on the G-28. Recommended using the latest Adobe software and Internet Explorer.

**DACA:** USCIS resumed accepting DACA renewals. DACA beneficiaries with the expiration date on and after September 5, 2016 may renew their DACA. DACA beneficiaries with expiration date before September 5, 2016 may request DACA as if this is an initial request. USCIS does not accept DACA initial requests and advance parole requests.

**N-400:** individuals can submit applications for citizenship on-line now. They must create an user-account, pay on-line, and view case status on-line. The exceptions are for military citizenship applications, those applying outside of the US, and citizenship application fee waivers.

**IMMIGRATION COURT:** On January 18, 2018, the Executive Office of Immigration Review (EOIR) issued new guidelines in motions to change venue to address the Immigration Court case-load as well as to avoid unnecessary delays.

**STAKEHOLDERS MEETING:** The Miami Immigration Court is going to hold a stakeholders meeting in the coming months.

**EDUCATION SUBCOMMITTEE MINUTES – FEBRUARY 2018**

**ADULT EDUCATION SUBCOMMITTEE MEETING**

**February 8, 2018**

- REVEST successfully began classes for the current cycle on January 10<sup>th</sup>, 2018 and we currently have over 1800 students registered for VESOL classes in our four Centers. The term will end on April 28<sup>th</sup>, 2018. Regarding the Summer Term 2185(May 9-August 25, 2018) 33 Orientation Sessions are scheduled. About 1000 students will be tested using the Pre-CASAS placement test. 84 classes are programmed for the Summer Term.
- REVEST continues registrations for the Spring 2183, and we have already served around 80 new vocational students despite the dramatic cuts in our budget recently. We continue to hold individual and group vocational retraining sessions for advisors, with the participation of CE coordinators, in order to continually help us expand our knowledge about the new changes in the MDC Information System.
- Faculty meetings were conducted with all REVEST instructors Jan. 18, 19, 2018. Topics included establishing a Florida I.D. to assist in establishing Florida residency, professionalism in the workplace, and strategies to enhance student retention.
- REVEST is concerned with the possible impact of the current climate regarding immigration and its effect on clients seeking services. We have noticed a decline in inquiries for services and are interested if any other agencies are experiencing similar effects. There may be a fear of disclosing personal information that is keeping some clients from seeking benefits they are eligible for.



- The total enrollment in the SAVES program as of January 31, 2018, was 2,052. Of these, 606 are new students to the program and 196 are 16 to 18 youngsters enrolled in the Success Management Academy (SMA) SAVES GED in Spanish Program. The current trimester began on January 8, 2018 and will end on Friday, April 06, 2018. The next academic trimester will begin on April 9, 2018. Graduations for students in the SAVES program are held at the end of each term.
- SMA GED in Spanish program is proven to be an excellent alternative for refugee youth that would otherwise not make it in the regular high school programs. Students are graduating and continuing to study English and choosing a career pathway either through vocational/technical training or transitioning to MDC. Due to the success of this program, the M-DCPS Superintendent and the School Board On January 25, 2018, were briefed about its implementation and achievements.
- To facilitate student access to the GED in Spanish SAVES program, this program is available in 8 schools around Miami Dade County: (1) Hialeah-Gardens SHS, (2) Westland Hialeah SHS, (3) Hialeah Adult Education Center, (4) Hialeah-Miami Lakes Adult Education Center, (5) Miami Springs Adult Education Center, (6) Robert Morgan Educational Center and Technical College, (7) Miami Coral Park Adult Education Center, and (8) Jose Marti Mast 6-12 Academy.
- Miami Sunset Adult Education Center has been added to the list of SAVES schools. As of now, SAVES has a total of 16 schools.
- SAVES continues to issue vouchers for books and tuitions for students who are ready and interested in vocational/technical courses that are not offered at their current schools. Some of these courses are: Aircraft/Airframe Mechanics and Truck Driving. Participating schools are Baker Aviation and Miami Lakes Technical Colleges. SAVES has 33 students in these schools.
- SAVES works closely with the M-DCPS marketing department to reach out to the community and disseminate information about the SAVES programs. SAVES is currently advertising via newspaper, radio, career fairs, and opening of school meetings. New SAVES Website and Marketing Video for M-DCPS technical colleges are available through the following links: [www.savesdadeschools.com](http://www.savesdadeschools.com) and <https://youtu.be/pttdZJ5ssLw>. Also the M-DCPS Parent Academy is being used as a vehicle to market the SAVES program.
