#### **Parolee Orientation (POP)**

- 849 parolees were processed in February 2013.
- Since October 1, 2012 to February 2013, 3627 Cuban parolees' have been processed through Parolee Orientation Program at CWS.

#### **Other Items**

- 1. Mabel Hernandez presented on the challenges the LGBT Refugees and Asylees face before, during, and after resettlement. Among the points she talked about were:
  - Definitions and Diversity: Understanding Sexuality and Gender
  - Personal Reflections on the LGBT Community
  - Sexual Orientation & Gender Identity in Different Cultural Contexts
  - LGBT Refugees' and Asylees' Experiences
  - LGBT Refugees' and Asylees' Needs & Building Capacity
  - Creating a Safe and Inclusive Environment
  - Case Management: Employment and Housing.

She mentioned that recognizing a gap in the resettlement network's response to lesbian, gay, bisexual, and transgender (LGBT) refugees and asylees, the US Office of Refugee Resettlement (ORR) awarded funding to Heartland Alliance to establish the Rainbow Welcome Initiative. The Rainbow Welcome Initiative supports the resettlement of LGBT refugees and asylees by offering on-site and remote technical assistance, and developing and aggregating resources for service providers, community members, and refugees and asylees.

She also informed that CWS is now able to provide training and guidance to refugee services providers the area.

- 2. Ileana Ceberio and Silvia Lopez from Community Medical Group attended the meeting and informed that CMG in conjunction with Resettlement Agencies will be participating in the celebration of World Refugee Day. They offer to share resources, information and donations during the event on June 14, 2013.
- 3. Melissa Pierre, from Gulf Coast Jewish Family and Community Services [resented the Refugee Services Program. Melissa informed Volags that the program focuses on:
  - Orientations to US Schools for K-12 students and their parents.
  - Offers tutoring in English and Match.
  - Support and Enrichment Services to 6-12 graders
  - Serves as Schools Liaison and provides FCAT preparations, educational filed trips and more.
  - Provides Career Services to High School Students and teach them how to get a job, apply for college and financial aid.

The Immigration and Legal Issues Subcommittee meeting was held on February 7, 2013 at the offices of World Relief where Berta Cassidy introduced to the members Eileen Lopez-Tome, Acting Chief of Staff for Miami District Office and provided the USCIS update and answered questions as follows:

- USCIS FORM IMPROVEMENTS INITIATIVE. USCIS announces improvements in some of their forms. Some of the improvements are easy-to-use formats, user-friendly look and feel, centralized processing, new data collection technologies and enhanced web content. The latest form improvements include the I-90, I-601, N-336, N-600, I-140 and N-470. Form I-90 is going to be the first using this technology. The current edition dated 12/17/2012 is being accepted now as well as the edition dated 08/10/2009 until April 16, 2013. After April 16, 2013 they will only accept the 12/17/2012 edition. The new edition has 2D barcode technology.
- **I-485 DELAYS.** Delays on I-485 applications are still ongoing at the California Service Center.
- **IMMOKALEE.** USCIS is going to Immokalee to provide information and counter service including infopass availability, scheduling of cases and outreach. Guadalupe Center is working with Catholic Charities.
- **MOBILE SERVICES.** USCIS is planning a mobile service in Key West in March or April.
- **INFOPASS.** Miami Field Office has limited infopass availability due to staffing issues.
- **PENDING CASES FOR A YEAR.** Contact Field Office Directors or Section Chief with cases that have been pending for more than a year and after 3 infopass appointments.

• IMPLEMENTATION OF NEW USCIS IMMIGRANT FEE. On February 1, 2013 USCIS began collecting a new USCIS immigrant fee of \$165.00 from foreign nationals seeking permanent residence in the United States. Any individual who receives an immigrant visa package from a U.S. consulate or embassy must pay this fee. Immigrant visa holders must pay online through the USCIS website after they receive their visa package from DOS (Department of State) and before they depart for the U.S. Immigrant visa holders will receive specific information on how to submit their payment whey they receive their visa package from DOS. Cuban Family Reunification Parolees do not have to pay this fee.

#### **EDUCATION SUBCOMMITTEE REPORT FOR FEBRUARY 8, 2013**

- REVEST currently has over 2500 students enrolled in VESOL classes and over 230
   Vocational students enrolled. The current REVEST term began January 8<sup>th</sup> and will run through April 25<sup>th</sup> of 2013. We are very pleased enrollment numbers.
- Faculty meetings for all REVEST instructors took place January 17<sup>th</sup> and 25<sup>th</sup> at the Hialeah Outreach Center, West-Dade Outreach Center, Kendal Outreach Center, and Wolfson Center. Topics included establishing I.D. requirements for instate tuition residency and professionalism in the workplace. Future faculty meetings will take place Feb. 14<sup>th</sup> and 22<sup>nd</sup>, 2013. Topics will include techniques in conducting vocational training such as preparing a resume, executing a job search and student preparation for job interviews.
- The REVEST Program is currently giving appointments for new student orientations in preparation for the summer term. Registration for vocational courses starts March 4, 2013 for the summer term.
- On January 24, REVEST Advisors met with Cassandra Okonkwo and Yleinia Galeano from Gulf Coast Jewish Family & Community Services regarding a new youth and family program. The program was developed to assist newly arriving refugee youth with following areas: tutoring, career exploration, job readiness, preparation with FCAT, cultural education and orientation to U.S. schools for both student and parents. Our Advisors will be visiting classes this week to inform our students about these great possibilities for their children.
- On November 30, REVEST Advisors from the Hialeah Outreach Center met with Youth Co-Op regarding a new youth program. This program was geared to improve parental involvement, school attendance, graduation rate and basic skills. Our Advisors were able to gather the names of the students who were selected. Youth Co-op will be conducting an orientation session during the three schedules morning, evening and weekend.
- On March 7<sup>th</sup> all REVEST Advisors and several administrators will be participating in eligibility training. The training will take place at the State Building in downtown.

- The total SAVES Program enrollment as of February 4, 2013, is **3,587**. Of these, **1,549** are new students to the program. The current trimester ends on April 18, 2013. The next academic trimester will begin on April 22, 2013.
- Currently, we are still registering and enrolling students in the ESOL and AGE programs. Enrollment into ESOL classes closes within the first two weeks of February to ensure students have sufficient time to posttest.
- SAVES continues offering evaluation and translation services to its students through Joseph & Silny. The last session was held on January 29. The next one will be on March 12, 2013.
   Students greatly benefit from these services since they facilitate the process of finding employment.
- New SAVES success stories, which highlight the achievements of some of our students, have been uploaded to the SAVES website (<a href="http://saves.dadeschools.net">http://saves.dadeschools.net</a>)
- Career Pathways, a new initiative implemented by MDCP-S, will benefit SAVES students.
   Students will enroll in a mandatory 12 hour orientation course before being registered into
   their ESOL/ABE courses. This course will assist students in creating an educational plan,
   writing short/long term goals, and becoming informed with all vocational/technical
   programs, requirements, and opportunities available to them. This orientation has proven to
   keep students on track and improve attendance and performance.
- The next SAVES Program District Meeting will take place on Wednesday, March 6, 2013 from 3 P.M. to 5 P.M. at Lindsey Hopkins Technical Education Center. Please contact our office if you are interested in attending and/or presenting.

<u>Claudio Micielli, MPH, Refugee Health Assessment Program Administrator</u> from the Department of Health Refugee Clinic provided a detailed program overview. The goals of the Refugee Health Assessment Program are:

Goal # 1: Provide culturally sensitive health assessment, immunization, and referral for follow-up health care services to eligible newly arriving refugees in Miami-Dade County.

Goal # 2: Protect the health of the general population in Miami-Dade County by identifying eligible newly arriving refugees with communicable diseases of potential public health importance.

Goal # 3: Reduce and/or eliminate health-related barriers that adversely impact on the effective resettlement of eligible newly arriving refugees in Miami-Dade County.

An average of 18,000 refugees are served every year in Miami-Dade County.

<u>Marta Pizarro, Program Developer, Citrus Health Network, Inc.</u> provided a detailed program overview on the Primary Health services they offer in Miami-Dade County. Requests for services consistently surpass projections. Citrus Health Network is well known and trusted in the community. Services offered by CHN includes:

#### FLORIDA HIGHWAY SAFETY & MOTOR VEHICLE - MARCH 2013

Modesto Burgos provided the following community update bulletin.

Information of Interest to Florida Drivers

Florida's Doors and Roadways Remain Open to Visitors: Whether you fly or drive to Florida, visitors can be assured the Sunshine State is doing business as usual. In an effort to widely communicate a reassuring message, DHSMV released a statement to the media around the world that the Florida Highway Patrol will defer enforcement of a law that requires visitors from outside the United States to have an International Driving Permit to drive lawfully in Florida. The statement explained that the law may potentially conflict with an international treaty.

The Department understands the concerns of the international community and is working with its partners to ensure that visitors are not inconvenienced. Visit Florida, AAA, Canada Automobile Association and law enforcement agencies around the state are helping DHSMV get the message out that Florida's doors and roadways are open as usual to all visitors.

The Department will be working with the Florida Legislature in the coming months to ensure that the law reflects Florida's rich history of welcoming our friends from around the world to the Sunshine State.

Homeland Security Gives DHSMV Thumbs Up on Real ID Compliance: A star in a circle on new driver licenses reflects a great accomplishment by DHSMV. The star indicates Florida has met federal standards for Real ID compliance. The Department of Homeland Security authorized the designation after DHSMV showed its comprehensive work to get the word out on the new requirements. Outreach included creating the *GatherGoGet* awareness campaign, training classes and database improvements. The new star soon will appear on licenses and identification cards. Customers do not need to replace their licenses. Current licenses with a plain gold star are Real ID compliant and will be recognized at airports, federal buildings and other such facilities.

<u>Upgrade to Driver License System Improves Over-the-Counter Service:</u> DHSMV recently upgraded the Florida Driver License Issuance System with Verification of Legal Status software. VLS connects DHSMV to the Department of Homeland Security's system to verify immigration documentation instantly, giving DHSMV the ability to issue credentials to eligible non-citizens over-the-counter. Prior to installing VLS, non-citizens eligible for a Florida credential had to wait for their credential in the mail following an office visit. Since the Dec. 17 upgrade, 79 percent of non-immigrants and 97 percent of immigrants have received their credentials over-the-counter.

The VLS process saves the Department mailing costs, reduces headquarters staff workload and reduces the number of customer inquiry calls.

**E-titles:** Have you ever found yourself in a situation where you needed your vehicle or vessel title and couldn't find it? Previously, to obtain a duplicate paper title, you had to visit a tax collector's office and pay approximately \$75. Now, the Florida Department of Highway Safety and Motor Vehicles offers an easier, cheaper and safer way to handle your titles. DHSMV can hold your title electronically in an e-title. E-titles are motor vehicle, mobile home or vessel titles held in an electronic form by the Department. E-titles prove ownership of a motor vehicle, mobile home or vessel the same way a paper title does. An e-title also simplifies the communications between the vehicle owner, the lienholder and the agency. An e-title also reduces title fraud.

<u>FHP Welcomes 52 New Troopers to Field Operations:</u> Fifty-two new troopers are ready to get to work. The 123rd Basic Recruit Class graduated from the Florida Highway Patrol Academy at ceremony at the Tallahassee Automobile Museum. Family and friends gathered to celebrate the accomplishment that marks the completion of a demanding 30-week training program that prepares recruits for a career as a Florida State Trooper.

During their time at the FHP Academy in North Florida, the recruits volunteered at events to raise money for the Ronald McDonald House. They visited Pyramid, Inc., an organization that provides workforce and lifestyle programs for developmentally disabled adults and with whom the academy has developed a special relationship. The recruits also participated in two blood drives for the Southeastern Community Blood Center, all while learning how to be the kind of public servant Florida needs and deserves.

Nearly 70,000 Crashes Go from Bad to Worse: Florida has seen an increase of fatal hit-and-run crashes during the last two years. The Florida Highway Patrol is partnering with the Florida Sheriffs Association, the Florida Police of Chiefs Association and the Florida Department of Transportation to combat the problem. The campaign aims to reduce the number of hit-and-run crashes in Florida by educating drivers on their responsibilities if involved in a crash and the consequences they face if they leave a crash scene. Fraudsters Use Agency's Name and Email Address for Phishing Expedition: The Florida Department of Highway Safety and Motor Vehicles warns the public to be aware of an email spam that has surfaced online. Fraudsters are using the Department's name and email address, <code>DoNotReply@flhsmv.gov</code>, to send emails that appear to be from DHSMV. The emails look like receipts from online transactions with the Department and include confirmation and tracking numbers. The numbers are not DHSMV tracking numbers, and the email addresses of the recipients did not come from DHSMV's database.

An indicator that the email is fraudulent is that it comes from two senders:

<u>DoNotReply@flhsmv.gov</u> and another address that varies and may look like a personal email address. All Department email addresses contain @flhsmv.gov as the domain, and DHSMV does not send transactional receipts from personal email addresses. If you receive one of these emails and did not make a recent transaction, we recommend that you delete the message. If you have

already opened the message, do not click any of the links within it. The emails are not from DHSMV, and the links embedded within take recipients to non-DHSMV websites that may contain malware.

DHSMV wants the public to understand our system has not been hacked, and we have numerous measures in place to protect customers' information. Rather, this is a type of spam where an email is made to look like it is from a trusted source and aims to trick the recipient into following a link that will lead to a website with malware. The name for this type of spam is "phishing." DHSMV makes information security a top priority, and we aim to provide consumers with information they can use to protect themselves from scammers by sharing this information with the public.

**Documentation Requirements in Florida:** We strongly recommend our customers visit <a href="https://www.GatherGoGet.com">www.GatherGoGet.com</a>, a website dedicated to assist Floridians with driver license and identification card requirements. Floridians renewing or obtaining a new license or ID are required to show proof of: 1) identification, 2) Social Security number and 3) residential address (two items). The website and its tools are also available in Spanish at <a href="https://www.ReunaVengaObtenga.com">www.ReunaVengaObtenga.com</a> and in Creole at <a href="https://www.RasanbleAlePran.com">www.RasanbleAlePran.com</a>. The Department is issuing driver licenses and identification cards that meet new federal standards.

An Appointment will Help: All customers who must visit one of our offices to renew, replace, or file a change of address to their driver license or identification card, are urged to secure an appointment prior to their visit. #### **USCIS UPDATE FOR FEBRUARY 2013**

**USCIS Form Improvements Initiative** – Recently, USCIS has improved a number of its forms with easy to use formats, user-friendly look and feel, new data collection technologies, etc.

Provisional Unlawful Presence Waiver Final Rule – On January 2nd, Secretary of Homeland Security Janet Napolitano announced the posting of a final rule in the Federal Register that reduces the time U.S. citizens are separated from their immediate relatives (spouse, children and parents), who are in the process of obtaining visas to become lawful permanent residents of the United States under certain circumstances. The final rule establishes a process that allows certain individuals to apply for a provisional unlawful presence waiver before they depart the United States to attend immigrant visa interviews in their countries of origin. The process is effective on March 4, 2013.
