## BROWARD COUNTY REFUGEE TASK FORCE MEETING

### **INTRODUCTION**

The meeting was held via a conference call and Miriam Rosario, Southeast Region (SER) Community Liaison (CL), Refugee Services (RS) Program, Florida Department of Children and Families (DCF) facilitated the Refugee Task Force (RTF) meeting. Miriam thanked and welcomed all participants for calling in and joining the meeting. The meeting was called to order and participants introduced themselves, services, and the agency they represented. Approximately 40 people joined the call.

### **SPECIAL PRESENTATION**

Liza Zamd, Senior Trial Attorney, **U.S. Department of Justice, Civil Rights Division, Immigrant and Employee Rights Section**, provided an overview presentation on their Immigrant and Employee Rights (IER) services to the nation. She focuses on the refugee community and how DOJ services and their relationship with other US department can collaborate for the best of all. Some of the topics; specifically cover how employers can hire workers who have not yet received their SSNs, she discuss less traditional employment documents like Transportation Boarding Letters and asylee foils, and ways in which IER can help refugees/asylees beyond the work DOJ do. For example, if a DMV incorrectly rejects an I-94 as proof of status, IER can call the DMV to try to remedy the situation. Similarly, if a bank does not give a refugee/asylee a loan because the person does not have an EAD, IER can call the bank to explain refugee/asylee permanent work authorization. Rebecca Miele, Florida KidCare (KC), Outreach Program Manager, Florida Department of Health, Broward provided the **KidCare and Market Place update**. Discuss the Florida KidCare Program, information to educate partners on matters of importance to families, discussed issues and barriers with enrollment and assist partners with resolution of client issues; areas of concerns such as especially the announcement for the breach and how to direct the families. Broward county/ Statewide Enrollment numbers – KC is going down since 1/2020 Medicaid is increasing. Medikids Full Pay Program has increased. The full pay program was \$157 per child, which has now increased to \$187.96 per child. Rebecca provided the information for the KC Early Tax Season Documents and HealthyKids Website and System Information Breach and the resources

**U.S. Citizenship and Immigration Services (USCIS),** Roketa Mansfield, Community Relations Officer (CRO), USCIS, Miami and Caribbean District, participated. Designation of Venezuela for TPS and Implementation of DED Venezuela:

The Department of Homeland Security today published a Federal Register notice (FRN) announcing the designation of Venezuela for Temporary Protected Status (TPS) for 18 months, effective March 9, 2021, through Sept. 9, 2022. <https://www.uscis.gov/green-card/green-card-processes-and-procedures/public-charge>

The FRN details the eligibility criteria Venezuelan nationals (and individuals without nationality who last habitually resided in Venezuela) must meet and describes procedures necessary to submit an initial TPS application and apply for an Employment Authorization Document (EAD).

Additionally, the FRN provides information about Deferred Enforced Departure (DED) for covered Venezuelan nationals (and individuals without nationality who last habitually resided in Venezuela) and how to apply for DED-related EADs.

The Public Charge Final Rule:

On March 9, 2021, the Seventh Circuit lifted its stay and the U.S. District Court for the Northern District of Illinois' order vacating the Public Charge Final Rule went into effect. When the vacatur went into effect, USCIS immediately stopped applying the Public Charge Final Rule to

all pending applications and petitions that would have been subject to the rule. USCIS continues to apply the public charge inadmissibility statute, including consideration of the statutory minimum factors in the totality of the circumstances, in accordance with the 1999 Interim Field Guidance that was in place before the Public Charge Final Rule was implemented. In addition, USCIS will no longer apply the separate, but related, “public benefits condition” to applications or petitions for extension of nonimmigrant stay and change of nonimmigrant status. #### Important Updates Regarding the 2020 Version of the Civics Test:

On Dec. 1, 2020, USCIS implemented a revised version of the civics test for naturalization (2020 civics test). Due to recent policy changes, some applicants required to take the 2020 civics test may now have a choice to take the 2020 test or the 2008 civics test. Please note that beginning on April 19, 2021, USCIS will only offer the 2008 civics test at the initial interview appointment regardless of filing date.

- If you are taking the 2020 civics test, find study materials on the Study for the Test (2020 version) page.
- If you are taking the 2008 civics test, find study materials on the Study for the Test (2008 version) page
- If you filed your Form N-400, Application for Naturalization on or after December 1, 2020 and before March 1, 2021, and are currently scheduled for your initial examination (interview) before April 19, 2021, you may choose to take the 2008 or 2020 civics test. All others will be required to take the 2008 civics test.
- To help determine if you are required to take the 2008 civics test, or if you can choose between the 2008 and 2020 civics test, follow these two steps:
  - 1) Check your filing date, also known as a “received date” on your N-400 notice at the top left corner (see sample notice to the right).
  - 2) Once you have your received date, go to the table below and find which scenario applies to you based on your filing and initial examination dates.

### **RS Contracted providers:**

**St. Thomas Human Rights Instituted (STHRI):** Christine Reis, Director Attorney, STHRI, reported various challenges for Cuban and Haitian arrivals including lack of employment authorization document (EAD) or an avenue to obtain work permit and difficulty to apply for asylum. Carlos Naranjo, Resettlement Coordinator, CWS, noted a recent EAD applications are being processed more quickly. Christine Reis, Director Attorney informed the task force that they are providing RS legal services in Broward at a co-location with CWS. The telephone number is 954-361-3350.

**Project RENEW/Broward College (PR/BC):** Jocelyn Martinez, PR/BC Director reported on their 202 enrollments for this semester. PR/BC offers orientation including access to computer usages and application. The students will need further contact refresher in computer skill. To help the students the classrooms are virtual or open in campuses with smaller groups following DC guidelines. Teacher spend lots of time educating on basics computers skills. PR/BC is still offering 25 laptops, to borough and as a n incentive to reregistering to the next semester.

**Comprehensive Refugee Services (CRS);** Francisco Figueroa, Program Administrator, Church World Service (CWS) provided overview information on the World Refugee Day. The CRS organizations will get together and will organize other activities as last year.
