## ORLANDO AREA REFUGEE TASK FORCE MEETING

### INTRODUCTION

This meeting was held through Microsoft Teams. Approximately 44 people were in attendance. Rosa Chaves, Community Liaison for the Central Region, led this meeting. Everyone introduced themselves and the agencies that they represented through the Microsoft Teams chat.

### SPECIAL PRESENTATION

- **Vanessa McCarthy – Catholic Charities Director of Comprehensive Refugee & Immigration Services** provided an overview of their services for refugees and all programs. They discuss the Youth and Mentoring Programs, Employment, Adult Education, and Legal Services.

### GENERAL UPDATES/ ANNOUNCEMENTS

- **Vesna Bozic, USCIS Community Relations Officer**, informed the task force that Temporary Protected Status (TPS) is available for certain countries (Venezuelans, Haitians, etc.). The Orlando USCIS Field Office has a new Director, Michael McLeary, who was previously a director in Boston. A quarterly stakeholder meeting will be held in September.
- **Anne Packham, Marketplace Project Coordinator** informed the task force that if a client is outside the enrollment window but receives an EAD, this client may apply for insurance on the Marketplace (they have 60 days to do so).
- **Kathy Walker, DOH Orange County** announced that their nurse in the refugee program will retire on September 15. They are in the process of hiring a new one. They are currently experiencing a backlog, however if a client needs help, they can call 407-723-4156 to ask for an appointment.
- **Fatima Ait Rami – Islamic Center of Orlando ICOrlando** announced that they have a surplus of backpacks. Anyone that needs some can ask her.
- **Laquita Moore – DOH Orange County** announced that she has been working in the refugee program for three years and is now is hired as a new Nurse Supervisor for TB and Refugee Health in Orange County.

- **Vanessa McCarthy – Catholic Charities CRS Director** let the task force know that they have seen an increase in clients.
- **Shaimaa Elawdan – Catholic Charities – ESL Program Manager Adult Education**, stated that AE has seen increased enrollment in their ESOL classes. Currently they have two physical English classes, one on site and one in Orlo Vista. Online classes are ongoing. Youth and Mentoring programs have also increased in clients since July 2021.
- **Rae Wilburn – AmeriCorps/Vista Program at Catholic Charities** let the task force know that they are having issues recruiting volunteers. Mentors should remain with the program for at least six months.
- **Alphonse Lindor – Haitian Services Specialist from Pine Hill's Neighborhood Center for Families** announced they have regular vaccines in Taft office this week and Bithlo office next week and are accepting walk-ins and appointments. - **Safriya King-Grimshaw – Bays Kids Program Director** announced they have a new therapist on staff and can now assist English and Spanish speakers. They can assist youth in Orange County.
- **Hillary Copp – Department of Children and Families Contract Manager**, is the new Contract Manager for the Central Florida contract (Catholic Charities).
