**SUBJECT:** 2016 Federal Child and Family Services Review

**PURPOSE:** The purpose of this memorandum is to summarize planning activities for the 2016 federal Child and Family Services Review (CFSR) and provide information to leadership at the state and local level so that regions and community-based care (CBC) lead agencies take appropriate action to ensure Florida is successful in conducting its first state led CFSR review.

**BACKGROUND:** The CFSR is a review process the federal government uses to assess how states are doing in their efforts to ensure children and families receive quality services through the child welfare system. The reviews identify strengths and areas needing improvement in safety, permanency and well-being. In addition, the reviews ensure that federal funds are appropriately spent, enable the collection of data that will inform national policy, and assist states in becoming self-evaluating over time. The CFSR examines child welfare practice using three approaches: a Statewide Assessment, an on-site case review, and stakeholder interviews.

1. The Statewide Assessment evaluates the child welfare system utilizing data from the most recent submission to the Adoption and Foster Care Analysis and Reporting System (AFCARS) and the National Child Abuse and Neglect Data System (NCANDS). The Statewide Assessment also considers qualitative data from quality assurance (QA) reviews, the 2015 CFSR statewide planning meeting, and other assessment activities conducted in 2015. As part of the assessment, the Office of Child Welfare (OCW) facilitated a statewide planning meeting in May 2015 with approximately 100 people attending, representing the regions, CBCs, Children's Legal Services, Office of State Court Administrator, case managers, child protective investigators, guardian ad litem, foster parents, and youth. During the meeting, participants completed a Strengths, Weaknesses, Opportunities and Threats (S.W.O.T.) assessment that became the foundation for the CFSR Statewide Assessment.
2. The on-site case review includes case record reviews and case-specific stakeholder interviews. Beginning April 1 through September 30, 2016, CBC QA teams will lead on-site case reviews.

3. The Administration for Children and Families (ACF) will conduct stakeholder interviews with community members who interface with the child welfare system such as judges. ACF will identify the stakeholders and the regions will need to coordinate scheduling. ACF will only ask for stakeholder interviews after reviewing the Statewide Assessment and determining there are areas that need further clarification.

The 2016 CFSR will be the third such review since 2000; the second review occurred in 2008. In 2008, a federal team from the ACF led the review in three sites: Miami-Dade, Alachua and Seminole counties. Florida was subsequently placed under a federally mandated Program Improvement Plan (PIP) through December 2011.

In response to widespread state and national concerns about the CFSR process, the ACF made major revisions and now allows a state-conducted review approach. The Department, Florida Coalition for Children (FCC) QA subcommittee representatives, and other CBC QA managers worked with the ACF to ensure the Florida QA system met all case review requirements. In September 2015, Florida submitted a letter of intent to use the state-conducted review approach. ACF approved the application on December 8, 2015.

ACF also accepted Florida's proposal to review 80 cases over a six-month period with cases spread among all CBCs. CBC QA staff will lead the review teams with a requirement for participation of regional QA staff on each team. Regional participation is critical as Florida is a state-administered child welfare system and ultimately responsible for the quality of services provided in the child welfare system.

**ACTION REQUIRED:** The Office of Child Welfare is requesting that you commit and support staff to actively participate throughout the CFSR. It is our desire that the Department, stakeholders and partners, including CLS and Substance Abuse and Mental Health staff, work together to participate on review teams. In preparation for the review, the OCW and ACF are providing training February 9-11, 2016, in Orlando. OCW has been working with the regional QA managers and CBC QA managers to ensure all participants register for this training. Lastly, we are attaching and referencing a series of documents that will provide detailed information that may be helpful if you receive questions from the media and other stakeholders related to the CFSR.

This letter serves as Florida's application to utilize the state's child welfare quality assurance system to conduct case reviews for the 2016 Child and Family Services Reviews (CFSR). The Department of Children and Families has worked diligently to create a robust quality assurance system that engages our regions, Sheriffs, and community-based care lead agencies in the case review process. We believe we can demonstrate that the following criteria established by the Children's Bureau are currently in place or will be in place by the beginning of and throughout the case review period.

1. The state operates an internal case review process at least annually that assesses statewide practice performance for the key child welfare areas using a uniform sampling process and methodology.
2. The state has a process in place for ensuring accurate and consistent case review ratings.
3. The state uses the federal onsite review instrument and instructions using the sample and method established above to collect data to be used for the initial determination of conformity.

Thank you for the briefings and trainings the Children's Bureau has provided to prepare states for the third round of CFSRs. Ms. Sylvia Kim has been very helpful in providing information and guidance as we considered this decision.

Dear Mr. Carroll:

On September 8, 2014, the Children's Bureau received your letter of intent to use a state conducted case review approach for the purposes of completing the federally-mandated Child and Family Services Review (CFSR) consistent with Technical Bulletin #7. Florida provided information to the Children's Bureau which outlined your ability to meet the criteria for using your state case review process.

The Children's Bureau worked with your staff to verify Florida's ability to use its case review process consistent with the criteria in the technical bulletin. The Children's Bureau has determined that the state's case review process meets some, but not all of the criteria. Approval is pending on the state's completion of actions that demonstrate that Florida meet the remaining criteria identified below:


- Florida is required to submit the state review schedule that covers the 6 month period of April through September 2016 that includes the number of cases by jurisdiction, case type and review dates.
- Florida is required to submit a copy of the actual sample frame that will be used to identify the foster care by jurisdiction, numerical identifier, date of birth, current case plan goal, entry date, FIPS (Federal Information Processing Standard) county code.
- Florida is required to submit a copy of the actual sample frame that will be used to identify in-home cases by family name, and include case open date, case closure date (if applicable), case type and FIPS county code.
- The state is required to provide training to reviewers and quality assurance staff on conducting the review and interviews. The State has provided CB with the current draft training curriculum, however training regarding the following criteria was not addressed:

- Conducting case-related interviews;
- In-depth instructions on the Onsite Review Instrument (OSRI) and
- Quality assurance process for accuracy and consistency of ratings, tracking questions and issues during application of the OSRI.

The state must demonstrate to the Children's Bureau that the remaining criteria are met by December 1, 2015. The Children's Bureau is committed to working diligently with the state to meet the remaining case review criteria. The CB staff plan to observe the training and the case review and quality assurance processes to ensure that they are consistent with the criteria. If the state is unable to do so, the Children's Bureau will not use the state's own case review process and results for CFSR purposes and a traditional onsite review will be scheduled during the week June 20, 2016 as a collaborative effort between federal and state staff.

On September 8, 2014, the Children's Bureau received your letter of intent to use a state-conducted case review approach for the purpose of completing the federally-mandated Child and Family Services Review (CFSR) consistent with Technical Bulletin #7. Florida provided information to the Children's Bureau which outlined its ability to meet the criteria for using its state case review process.

In September 29, 2015 correspondence, we informed you that our review determined that Florida's proposed case review process met some, but not all of the criteria. Approval was pending the state's completion of the specified actions needed to demonstrate that Florida meets the identified criteria. We continued to work with you and your staff to verify Florida's ability to use its case review process consistent with the criteria in the technical bulletin.


The Children's Bureau has determined that the Florida case review process now meets the criteria in the technical bulletin and the Children's Bureau will use the state's case review process and results for the CFSR purposes. The Florida onsite period is April 1, 2016 through September 30, 2016. The Children's Bureau Regional Office will be in contact with you to continue planning for the review activities.

The Children's Bureau encourages the state to continue meeting the requirements for a fully functioning case review process. Following the CFSR, should the state be required to complete a program improvement plan, you may need to continue to conduct case reviews to measure and report improvements during your program improvement plan. The Children's Bureau remains committed to assisting the state in continuing its case review process.
