SUBJECT: Child and Family Services Review (CFSR) Round 3 Data Profile

PURPOSE: The purpose of this memorandum is to provide information on the Florida CFSR Data Profile and alert regions and CBCs that Florida's performance in 3 of the 7 federal data indicators will result in a federal Program Improvement Plan (PIP).

BACKGROUND: The Children's Bureau (CB) uses national standards for state performance on statewide data indicators to determine whether a state is in substantial conformity with two outcomes related to safety and permanency. Statewide data indicators are aggregate measures, and are calculated using administrative data available from a state's submissions to the Adoption and Foster Care Analysis and Reporting System (AFCARS) and the National Child Abuse and Neglect Data System (NCANDS). When a state is not in substantial conformity with a related outcome due to its performance on an indicator, the state must include that indicator in its program improvement plan. The improvement a state must achieve is relative to the state's baseline performance at the beginning of the program improvement plan period.

In an April 23, 2014, Federal Register notice (79 FR 22604), the CB proposed statewide data indicators and an approach to national standards for the third round of CFSRs that differed from that used for the second round of reviews. The indicators were revised based on public comment, research literature review, consultation with an expert panel, a review of the availability and quality of data available, and statistical testing to examine relationships between available data and outcomes.

A description of how each of the seven statewide data indicators are calculated is provided in the attached data dictionary. The seven statewide data indicators are described briefly below.

- 1. **Maltreatment in foster care.** This indicator is described as: Of all children in foster care during a 12-month period, what is the rate of victimization per day of foster care? Florida did not meet this performance indicator.
- 2. Recurrence of maltreatment. This indicator is described as: Of all children who were victims of a substantiated or indicated maltreatment report during a 12-month reporting period, what percent were victims of another substantiated or indicated maltreatment report within 12 months of their initial report?
- 3. Permanency in 12 months for children entering foster care. This indicator is described as: Of all children who enter foster care in a 12-month period, what percent are discharged to permanency within 12 months of entering foster care? Permanency, for the purposes of this indicator and the other permanency-in-12-months indicators, includes discharges from foster care to reunification with the child's parents or primary caregivers, living with a relative, guardianship, or adoption.
- 4. Permanency in 12 months for children in foster care 12 to 23 months. This indicator is described as: Of all children in foster care on the first day of a 12-month period who had been in foster care (in that episode) between 12 and 23 months, what percent discharged from foster care to permanency within 12 months of the first day of the period?
- 5. Permanency in 12 months for children in foster care for 24 months or longer. This indicator is described as: Of all children in foster care on the first day of a 12-month period who had been in foster care (in that episode) for 24 months or more, what percent discharged to permanency within 12 months of the first day?
- 6. **Re-entry to foster care in 12 months.** This indicator is described as: Of all children who enter foster care in a 12-month period who were discharged within 12 months to reunification, living with a relative, or guardianship, what percent reenter foster care within 12 months of their discharge? Florida did not meet this performance indicator.

7. **Placement stability.**This indicator is described as: Of all children who enter foster care in a 12-month period, what is the rate of placement moves per day of foster care? Florida did not meet this performance indicator.

ACTION REQUIRED: We are pleased that Florida has met the national standards in 4 of the 7 data indicators. During the next few weeks, we will be meeting with the CB to discuss potential strategies to improve performance. In the interim, Regional Managing Directors and CBC CEOs should begin local discussions to review local performance data and drivers to improve practice in the 3 areas where performance related to the national standards was not met. In early 2016, we will establish a workgroup to formalize Florida's strategies. The CB will set the baseline for the 3 data indicators at the completion of the case review component of the CFSR. At that time, we will provide the CB with our formal strategies to improve performance related to the national data indicators as part of the state PIP.

NCANDS Data Quality Checks

All of these checks are applied only to victims of maltreatment. A victim in CFSR 3 is a child for whom the state determined at least one maltreatment was substantiated or indicated and a disposition of substantiated or indicated was assigned for a child in a specific report. It does not include alternative response victims. It does include children who died and the death was confirmed to be the result of child abuse and neglect.
