Clarification of Due Process for Benefits for Young Adults Formerly in Foster

Care

**PURPOSE**: This memo is to provide clarification about due process requirements for services to young adults formerly in foster care applying for Road to Independence, Aftercare and/or Transitional Support services. This includes any case in which the decision is made to deny, reduce or terminate benefits. For further information, I have attached my memo dated July 28, 2009 entitled, "Services to Young Adults Formerly in Foster Care Spending Plan, Federal Minimum Wage Increase and Technical Assistance for Eligibility Determinations".

BACKGROUND: The spending plan referenced in the memo above is critical to this process. Lead agencies must document the funds available to provide independent living services. It is important to document funds from other sources used to supplement the specific allocation for independent living services. Lead agency's spending plans will be the source document regarding funding availability specified in Section 409.1451(5). Florida Statutes. The spending plan must be updated as new funds are available.

The Family Safety Program Office is aware of the substantial resources (beyond the specific independent living allocation) that lead agencies have contributed to supporting this vulnerable population. Last fiscal year, community-based care agencies used more than 6 million dollars beyond the legislative allocation to meet this need. We encourage continuation of this practice and appreciate your strong leadership in this arena.

#### Requirements

- The new minimum wage monthly amount must be included as a dollar figure on all correspondence related to applications and appeals for youth formerly in foster care. The maximum amount is \$1,256 per month.
- If the youth is receiving a reduced amount, the maximum monthly amount (\$1,256) must be included on the correspondence.
