Child Protective Investigation Notifications to Agency for Persons with

Disabilities (APD)

**PURPOSE:** The purpose of this memorandum is to reinforce the notification policy required when a child protective investigator conducts an investigation involving an APD client or any child placed in an APD licensed setting or facility.

**BACKGROUND:** Florida Statute 39.202(2) (h), F.S., grants the Agency for Person with Disabilities access to Department records, excluding the name of the reporter, for the purposes of administration or supervision of the agency's program to prevent, investigate or treat child abuse and for licensing activities.

The standard for timely notification to APD is explicitly defined in s. 39.302(1), which directs child protective investigators to notify the appropriate licensing agency upon receipt of a report alleging any individual acting in an official capacity has abused, neglected or abandoned a child.

**ACTION REQUESTED:** To operationalize the notification process, APD Headquarters has requested that child protective investigators use a regionally-based email Mailbox (see Regional Contact List attachment Column One) to meet the statutory mandate for timely notification. Steps 1 and 2 below relate to the initial notification process. Step 3 is required upon closure of the investigation. Please note these steps are all designated to be completed via written email notification.

1. Upon receipt of a report alleging that a child is an APD client and has been abused, neglect or abandoned, the CPI will provide the following information in the written email notification:

- 2. If the initial report or prior history check does not identify the alleged child victim as an APD client or the incident as occurring at an APD licensed facility, upon determination of the above the CPI must submit the email notification with the same information as above no later than the next working day.
- 3. At closure of the investigation, the CPI will submit an email notification providing the following information:
