SUBJECT:	FSFN Enhancement to document Virtual Contacts will deploy on August 7, 2020

**PURPOSE:** The purpose of this memorandum is to inform child welfare and adult investigations stakeholders of an enhancement that will be deployed within the Florida Safe Families Network (FSFN) on August 7, 2020. This enhancement will provide the ability to document a 'Virtual Contact'.

**BACKGROUND:** Beginning March 23, 2020, the Department of Children and Families transitioned to allowing tele-visits as a means for completing the 30-day face-to-face requirement outlined in federal and state policy. This guidance was put in place in an effort to ensure the safety of the staff conducting physical contact visits with children and families served through the child welfare system, including the children and caregivers for those served in out of home care and in home care, and children and families served through Family Support Services for high/very high risk families.

On the evening of August 7, 2020, an enhancement will be deployed within the FSFN system which will allow the identification of a 'Virtual Contact' when creating a note. This note type will be added to the following categories:

- Adult Investigation
- Case
- Independent Living
- Legal
- Post Adoption (also includes a new virtual contact for 1-year post communication)
- Special Conditions

Until the expiration or change of the executive order, the child welfare professional or adult protective professional should select the 'Virtual Contact' note type and document the completed face-to- face contact. 'Virtual Contact' should not be selected along with a 'Home Visit' as this does not supplement the required 30-day home visits in the child's current residence. Any virtual contact that is attempted and not completed should be

documented in the case note narrative. Additional circumstances in which 'Virtual Contact' can be selected along with a completed face-to-face are as follows:

- Family/Sibling Visitation
- Court hearing
- Staffing's (multidisciplinary, permanency, safety planning, reunification)
- Required monthly parent Contact by Child Welfare Professional
- School/Daycare visits

The type of technology used should also be documented within the narrative of the case note (e.g., Zoom, Skype, Google Duo, Microsoft Teams, etc.).
