SUBJECT: Second Party Review Credentialing - Required Training

Purpose: This memorandum provides information on mandatory training for all management staff completing 'In-Home Safety Assessment' second party reviews in the Florida Safe Families Network (FSFN).

Background: The Secretary's 'Action Plan to Improve Protective Investigations' initially established mandatory qualifications for provisional certification of second party reviewers. The prerequisites included (1) certification as a child protection professional; (2) three years work experience as a child protective investigator or child welfare caseworker; and, (3) one year experience in a supervisory or specialist role. Circuits were directed to submit a list of managers conducting second party reviews and their qualifications to the Family Safety Program Office for review and approval.

In addition to provisional certification, the action plan calls for training for managers designed to ensure appropriate decision-making on investigative outcomes. This initial round of training will focus on second party reviews in the 'In Home Safety Assessment' with follow-up training planned for enhancing reviews of Institutional Safety Assessments.

The In Home Safety Assessment training developed incorporates lessons learned from the Multiple Reports document and was piloted with a class of 12 second party reviewers. It is ready for release via a distance learning web cast format and <u>managers will have the option of participating in either session</u>. The Center for the Advancement of Child Welfare Practice, in conjunction with the Family Safety Program Office, will broadcast 'Quality Improvement in 2nd Party Reviews' web casts on the following dates and times. Web broadcast 'Live Meeting' capacity limits downloading to 23 computer terminals (with LCD projector) statewide. This allows for one site per circuit. Regional directors are encouraged to consider using a centralized training site to facilitate group interaction. At this time, the training will be limited to managers conducting second party reviews only.

Action Required: Please disseminate this memorandum to all managers conducting second party reviews in your circuit. To document attendance participants will have to "sign in" using the 'Live Meeting' functionality at the beginning of the web cast and initial the circuit's Second Party Reviewer List which is to be distributed at the end of the event (see attached). Additionally, participants will be asked to complete both a pre and post test (using non-identifying information) to assist the Family Safety Program Office in evaluating both the training format and training content. The tests scores will not be a factor in certification.

It is essential that circuits add any second party reviewers that were not provisionally certified last year to their updated reviewer lists, documenting the mandatory training and experience requirements (or include an exception request based on the reviewer having comparable training and experience). Certificates will be issued upon submission of the requested materials and the Family Safety Program Office Access database will reflect certification as a 'State of Florida Second Party Reviewer'.
