SUBJECT: Pre-Service Test Item Writing Workshops

PURPOSE: The purpose of this memo is to provide you with information regarding on-going efforts to refine the pre-service curriculum and testing content. A schedule of test item writing workshops is attached. We encourage Child Protective Investigators, Community-Based Care Case Managers/Supervisors, and Child Welfare Legal Services attorneys to participate. Workshops are being held throughout the state to ensure everyone has an opportunity to contribute and make both the curriculum and the test accurate and pertinent. In addition, we ask that providers consider hosting one of the workshops where there is not a location designated at this time.

BACKGROUND: This year, we are piloting and validating new classroom training posttests. Florida International University, charged with curriculum development, is conducting monthly test-item writing workshops across the state. The purpose of these workshops is to:

- 1. produce test questions for piloting; and,
- 2. identify appropriate pre-service classroom training content.

Your staff are asked to write and review actual pilot questions for the new test at these one and one-half-day workshops. They will also review the pre-service classroom training competencies and make recommendations about maintaining in the classroom training or moving to the field and/or in-service training components. Encouraging your staff to participate will ensure that your agency's feedback is incorporated into the finalized preservice classroom training and testing process.
