# **Executive Summary**

The Child Welfare Key Indicators Monthly Report presents key outcome, process, qualitative, workload, and resource indicators selected to provide a general overview of the current state of Florida's child welfare system.

#### Florida Abuse Hotline

Workload. Total contacts offered increased slightly to 43,339 in September, much lower than the average of 45,637 September 2013, 2014 and 2015.

**Timeliness.** The percent of calls abandoned by reporters on the English-language line increased from 10% in August to 15.6% in September. The abandonment rate on the Spanish-language line continued at below 25%.

**Screening Decisions.** Screen-in rates continue at just below 80% for maltreatment and special conditions.

#### **Child Protective Investigations**

Workload. 17,776 new investigations in September were a sharp increase over the 17,192 in August -- 9% higher than the 16,280 average for the last three Septembers. 26,272 active investigations on September 30 increased from 23,111 on August 31. The backlog increased by 14%, from 1,059 on August 31 to 1,207 (646 in Northwest) on September 30.

**Timeliness.** The statewide percent of alleged victims seen within 24 hours improved from 86.8% in August to 87.4% in September, but has declined since the last half of 2013. The percent of child protective investigations completed within 60 days declined slightly, from 93.1% for investigations begun in June to 91.7% in July, continuing the overall declining trend since the 99.5% level was the norm in 2012 and early 2013.

**Recurrence.** Recurrence of maltreatment within 12 months continues near the 9.1% national standard.

**Removals.** 1,407 children were removed in September, down from 1,506 children removed in August. The removal rate of 6.5 per 100 children investigated in July continues the upward trend since the 5.3 rate in March. The removal rate continues in the 5.0 to 7.0 range, above the 4.0 to 6.0 range that was normal through 2013.

#### **Community-Based Care Lead Agencies**

Caseloads. Monthly discharges slipped to 1,053 in September from the seasonal peak -- due to adoptions -- of 1,403 in June. The continuing gap between removals and discharges resulted in an increase in out-of-home care from 23,229 in August to 23,538 in September, the highest since 23,685 in May 2008. The trend for children receiving in-home services continues at around 12,000, just over half as many as in out-of-home care.

Child Safety. The percent of children with no verified maltreatment during case-managed in-home services improved slightly to 97.0% in April - June 2016. The maltreatment rate in out-of-home care of 13.2 per 100,000 days in April - June 2016 was not meeting the national standard of 8.5 or less.


**Timely Permanency.** Achievement of permanency within 12 months of entry of 41.5% for entries in July through September 2015 exceeds the national standard of 40.5%. Performance also remains high for children achieving permanency within 12-23 months and 24+ months, with each exceeding the national standards. The percent achieving permanency within 12 months who did not re-enter care within 12 months improved from 90.2% to 90.4%, but is below the national standard of 91.7%.

Placement Stability. Children entering care in October 2015 through September 2016 averaged 4.37 moves per 1,000 days in care, not meeting the national standard of 4.12 or fewer moves.

Placement in Removal County and Circuit. 36.2% of children are currently placed outside of their removal county and 19.4% are placed outside their removal circuit.

**Group Care.** Two areas have over 10% of children aged five and under in licensed care who are placed in group care placements, compared to six areas with none and 3.1% statewide.



#### **Workload Trends**


#### **Reporting Method Trends**

The Florida Abuse Hotline offers a variety of methods for citizens to report concerns about vulnerable adults and children. Total contacts and calls via the English line had the usual seasonal peak following the summer valley, but at a lower level than the last two years. Calls on the Spanish continued to increase.



#### Seasonality of Hotline Workload


Total contacts offered increased slightly to 43,339 in September, much lower than the average of 45,637 September 2013, 2014 and 2015. "Contacts Offered" include those abandoned by a caller who called back, so both initial attempts and completed calls from the same person are counted.



## **Screening Trends**


#### **Alleged Maltreatment Screening**

The 28,710 total child contacts in September 2016 increased slightly over 28,513 received in August. The gap of 3,292 between the 25,418 screened (20,070 screened in and 5,418 screened out) and the total is due primarily to 3,071 handled as "Information and Referral" calls, which have doubled from 1,396 September 2015. The percent screened-in level continues at the 79% level after the peak of 81% in December 2015.



#### **Special Conditions Screening**


The percent of special conditions screened in continued the recent downward trend, from a peak of 80.9% in July to 76.2% in September. However, the 1,633 screened in and 2,143 total special conditions (screened in and screened out) were the highest September counts in the last four years.


#### **Average and Maximum Times to Answer or Abandon**

Average wait times -- before answer by a Hotline counselor on the English-language line and before abandoning a call – increased slightly in September to 3:43 and 3:12, respectively. Maximum wait times also increased in September to 40:38 before answer and 41:38 before abandonment.




#### **Percent of Calls Abandoned**

The number of calls on the English-language line is over 20 times the number on the Spanish-language line. The percent of calls abandoned by reporters on the English-language line increased from 10% in August to 15.6% in September. The abandonment rate on the Spanish-language line continued at below 25%.




#### Florida Abuse Hotline Handling Time: Trend and Stratification

The Average Handling Time (AHT) of a counselor includes talk time and after call work time (ACW). Average talk time continued below the 12 minute level and ACW continued below the 22 minute level.

The Florida Abuse Hotline had four counselor separations in September 2016.





## **Investigative Workload Trend**


#### Incoming, Active, and Backlog Investigations

The 17,776 new investigations in September were a sharp increase over the 17,192 in August and was 9% higher than the 16,280 average for the last three Septembers. 26,272 active investigations on September 30 increased from 23,111 on August 31, with Circuits 9, 15, and 19 having the increases of around 30%. The backlog increased by 14%, from 1,059 on August 31 to 1,207 (646 in Northwest) on September 30.



## Maltreatment Investigations and Special Conditions Assessments

Although there are over ten times as many alleged maltreatment reports as special conditions referrals, the increase in special conditions referrals is much greater than the increase in alleged maltreatment.



#### Percent of Investigators with More Than 15 Active Investigations


#### Statewide Trend

The statewide percent of CPIs with more than 15 active investigations increased from 46.2% on August 31 to 56.2% in September 30, continuing the steady increase over the last four years, with seasonal variation, including drops in December and July.

In 17 of 23 areas, 50% or more CPIs had more than 15 active investigations on September 30, 2016.



#### **Percent of Alleged Child Victims Seen within 24 Hours**


#### Statewide Trend

The statewide percent of alleged victims seen within 24 hours improved from 86.8% in August to 87.4% in September, but has declined since the last half of 2013, with a sharp decline in April – July of this year. It is interesting that performance tended to decline each summer when the workload is lower.



#### Stratification by DCF Circuit and Sheriff's Office



#### Percent of Child Investigations Completed within 60 Days


#### Statewide Trend

The statewide percent of child protective investigations completed within 60 days declined slightly, from 93.1% for investigations begun in June to 91.7% in July, but the overall trend has decreased since the 99.5% level was the norm in 2012 and early 2013.

Eighteen circuits and sheriffs were above the 90% level investigations of new reports received in July 2016.




## Safety Determinations and Services Provided

These Tableau visualizations are for investigations closed between August 25 and October 24, 2016.


#### Impending Danger Threats and Safety Determination

This visualization indicates that some children have been determined "unsafe," yet have no impending danger (pink), while others are determined "safe," yet there is impending danger (dark blue). These anomalies need follow-up to determine whether there are issues with proper implementation of the practice model and/or with FSFN data entry.

This Tableau visualization indicates the percentage of the identified Impending Danger Threats for both safe and unsafe children, by region.




#### **Unsafe Children and Safe Children by Service Type**

These Tableau visualizations reflect investigations closed between August 25 and October 24, 2016.


- The visualization on the left indicates that some children have been determined "unsafe," yet have no services (red).

#### **Unsafe Children with No Services or Family Support Services**



## **Recurrence of Maltreatment after Verified Findings**


#### Statewide Trend

Recurrence within 12 months steadily improved and achieved the national standard of 9.1% or less in October 2013 through September 2014. Since October 2014 performance has been up and down in relation to the standard.



#### Stratification by Circuit and Sheriff's Office




#### Monthly Separations

There were 42 CPI and Senior CPI separations in September 2016, still high but a welcome drop from the peaks of 55 in November 2015 and August 2016.



#### Time in Classification

The percent of less experienced CPIs continues at a high level. From September 1 to October 3, the percent of the active workforce with less than six months of experience increased from 24.6% to 26.5%; the percent with less than one year of experience increased from 43.6% to 44.3%, and the percent with less than two years of experience decreased from 72.7% to 72.4%. 86.3% had less than three years of experience.




## Statewide Trend

1,407 children were removed in September, a dip from the 1,506 children removed in August. The removal rate of 6.5 per 100 children investigated in July continued the increasing trend since the 5.3 rate in March. The rate continues in the 5.0 to 7.0 range, rather than the 4.0 to 6.0 range that was normal until late 2013.



#### Removal Rate per 100 Children Investigated April-June 2016




## **Statewide Trends in Case-Managed Services**

There were 23,538 children in out-of-home care on September 30, a 5.0% increase over the 22,358 children in care on September 30, 2015 and a 23.5% increase over the 18,003 in care on September 30, 2013. The trend for children receiving in-home services has remained relatively flat for three years.




#### **Services Mix by CBC Lead Agency**

There continues to be variation among circuits in regards to in-home and out-of-home care services, with the widest variation occurring in use of Family Support Services.




#### Removals and Discharges Compared to Children in Out-of-Home Care Trend

The number of removals decreased from 1,506 in August to 1,407 in September, but the overall trend has been upward since the seasonal low of 1,192 in November. Monthly discharges slipped to 1,053 in September from the seasonal peak -- due to adoptions -- of 1,403 in June. The continuing gap resulted in an increase in out-of-home care from 23,229 in August to 23,538 in September, the highest since 23,685 in May 2008.




#### Placement Types Compared to Children in Out-of-Home Care Trend

The rise in children in out-of—home care over the last three years has been met primarily by increases in unlicensed kinship placements – relatives beginning in 2013; non-relatives in 2014. Over the last 12 months, the number of children in non-relative placements increased by 12.7%, while the number in relative placements increased by 4.0%., those in licensed family homes increased by 4.1%, those in group care increased by 4.9%, and those in "other" placements increased by 6.3%.

Ongoing Services Safety Methodology Implementation Status as of 10/23/2016





#### **Child Safety Trends: Comparison of Three Indicators**


Children continue to be safer while receiving services than after termination of services:

- The percent of children with no verified maltreatment during case-managed in-home services has been steady at around 97% for years and was 97.0% in April-June 2016.
- The percent of children with no verified maltreatment within six months after termination of casemanaged services improved for closures in October -December 2015 to 96.4%.
- The percent of children with no verified maltreatment within six months of termination of Family Support Services continued at a lower level than the other indicators, with closures in October -December 2015 at 94.7%.




#### Child Safety during Case-Managed In-Home Services

#### Child Safety in Out-of-Home Care


This measure is generated by taking the total number of reports with at least one verified maltreatment and dividing it by the total number of days in foster care for all children, with the result multiplied by 100,000 to calculate the rate of victimization per 100,000 days in foster care. The data for this quarter shows wide variation among the CBCs, with statewide performance not meeting the national standard of 8.50 or less.

Statewide performance for services terminated in October - December 2015 was 96.4%.


Percent of Children Terminated from Case Managed Services in Quarter Who Were Not Maltreated within Six Months, for Children with Services Terminated October-December 2015

Percent of Children Terminated from Family Support Services in Quarter Who Were Not Maltreated within Six Months, for Children with Services Terminated October-December 2015



## Permanency within 12 Months of Removal, by Quarter


#### Statewide Trend


Permanency within 12 Months of Removal is our primary indicator of timely permanency. Statewide performance has been slowly declining over the last few years to the point that the current level of 41.5% barely meets the national standard of 40.5%.

Eleven of the lead agencies exceed the national standard of 40.5%.






#### **Long-Term Trends on Three Permanency Indicators**






#### Permanency within 12 Months for Children in Care 12-23 Months




#### Permanency within 12 Months for Children in Care 24+ Months


#### Children in Care 24+ Months on 10/1/2015 Who Achieved Permanency Within an Additional 12 Months




Statewide performance for the most recent available quarter (entries two years ago) improved in the last two guraters. However, performance has remained below the national standard of 91.7% for entries since 2012. This new federal measure presents an incomplete picture of re-entry, selecting only children removed two years ago who achieved permanency within 12 months and did not return to out-of-home care within 12 months of achieving permanency.

Most areas need improvement on this indicator in order to meet the national standard of 91.7%.






## Reunification Goal after 15 Months & No Termination of Parental Rights Activity

The statewide average was 8.4% on September 30. Circuit goals are set for each period after review of baseline information.




#### **Timeliness of Termination of Parental Rights, from Petition to Order**

The statewide median is 58 days, much better than the statewide target of less than 90 days. Circuit goals are set for each six-month period after review of baseline information.



## **Placement Stability**


#### Statewide Trend

Statewide performance has been slightly better than the national standard of 4.12 moves per 1,000 days in foster care over the last few years, until increasing to 4.37 moves per 1,000 days in the last four quarters.









#### **Proximity of Placement to Maintain Connections**

Percent of Children in Licensed Out-of-Home Care Placed Outside of Removal County






#### Children Placed Outside Removal Circuit

The 19.4% currently placed outside of their removal circuit is lower than for the out-of-county indicator, as many children that are not placed in their home county are placed within their home circuit.


#### Percent of Children in Licensed Out-of-Home Care Placed Outside of Removal Circuit as of September 30, 2016


The number of children aged 6-12 in group care has increased sharply since 2014. However, there was a sharp reduction in both the 6-12 and 13-17 age groups in July and August.



#### Children in Group Care by Age Group




Thirteen lead agencies had less than one percent of these very young children placed in group care on September 30.



#### Children Aged 6-12 Placed in Group Care


The percentage of children in group care increases with age, with one CBC having more than twice the percentage of children aged 6-12 in group care compared to the statewide level.






#### Children Aged 13-17 Placed in Group Care

Most CBC lead agencies have 50% or more children in this age range placed in a group home environment, with six CBCs having over 80%.






#### Children Aged 0-17 Placed in Group Care

Statewide, almost one quarter of all children in licensed care aged 0-17 were placed in group care on September 30.


#### Percent of Children in Licensed Care Who Were Placed in Group Care as of 9/30/2016 Ages 0-17




#### Children with Consent for Prescribed Psychotropic Medications


In order to administer psychotropic medication to a foster child, parental consent or a court order must be obtained, unless the child is receiving inpatient services or a physician certifies that delay would be likely to harm the child. The statewide percentage of children with at least one prescribed psychotropic medication on November 2 was 98.6%. This chart provides the number with no consent and percentage with consent.



## Children Receiving Dental Services in Last Seven Months

Considerable progress has been made in the last few years with medical and dental services, with the statewide percent of children receiving recent dental services at 91.8% as of September 30.






# Young Adults Aging Out Enrolled in Education Programs

For children who don't achieve permanency prior to reaching adulthood, it is crucial that they are prepared for life after foster care by the time they "age out" of care. This is one indicator of that preparation for adulthood, but does not control for any of the many variables that influence this preparation, including time in care and the child's education level when entering care.



## Youths Served by CBC Lead Agencies and Juvenile Justice


#### Statewide Trend

The number of youths served by both the child welfare system and the juvenile justice system in the same month declined slightly in February and March, but increased in April and has remained at a higher level since that time. As this is a new indicator, we do not know whether this is a seasonal pattern.


The number of youths served by both systems is variable among the lead agencies, but is related to the total number of youths served by each lead agency.


## **Human Trafficking Intakes Trend**

The trend in monthly number of Human Trafficking Reports (Initial and Additional) accepted by the Hotline continued to increase, while the trend in percent with no indicators continued the long-term gradual decline.



## Children with Indication of Human Trafficking by CBC Lead Agency



# **Child Care Regulation**

## **Child Care Inspections per Month**

The percentages for both home and facility inspections continued at near-perfection, with timely home inspections at 98.9%% and timely facility inspections at 99.7%.
