

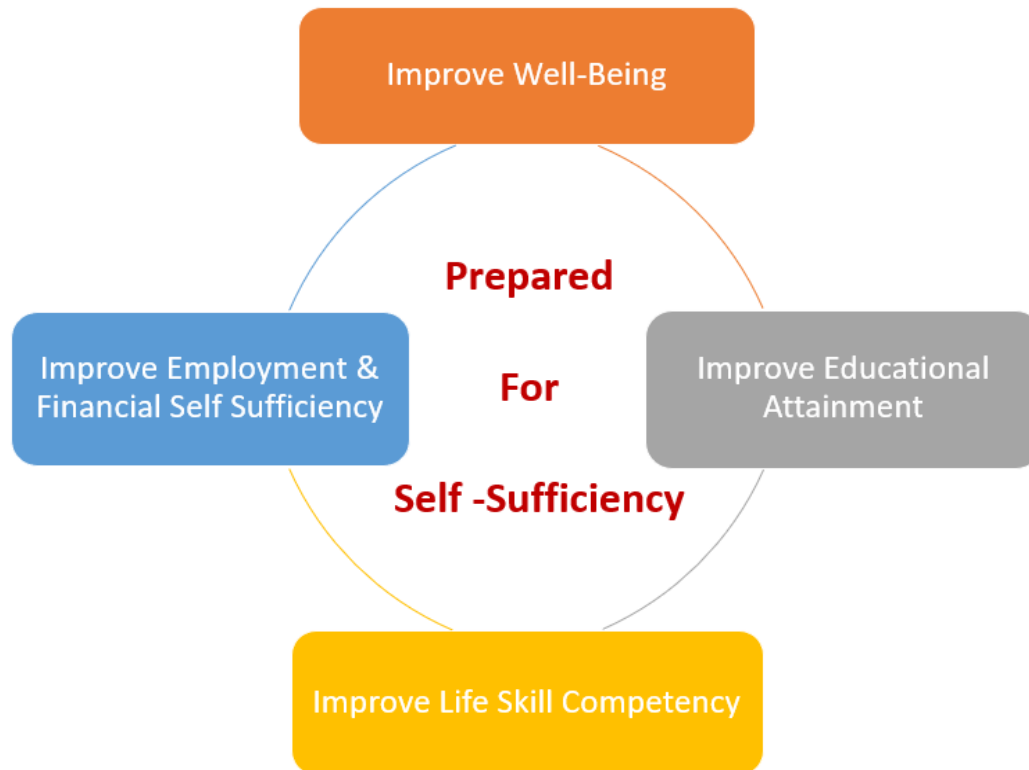
Florida Department of Children and Families Transition Services for Youth Job Aid

Overview:

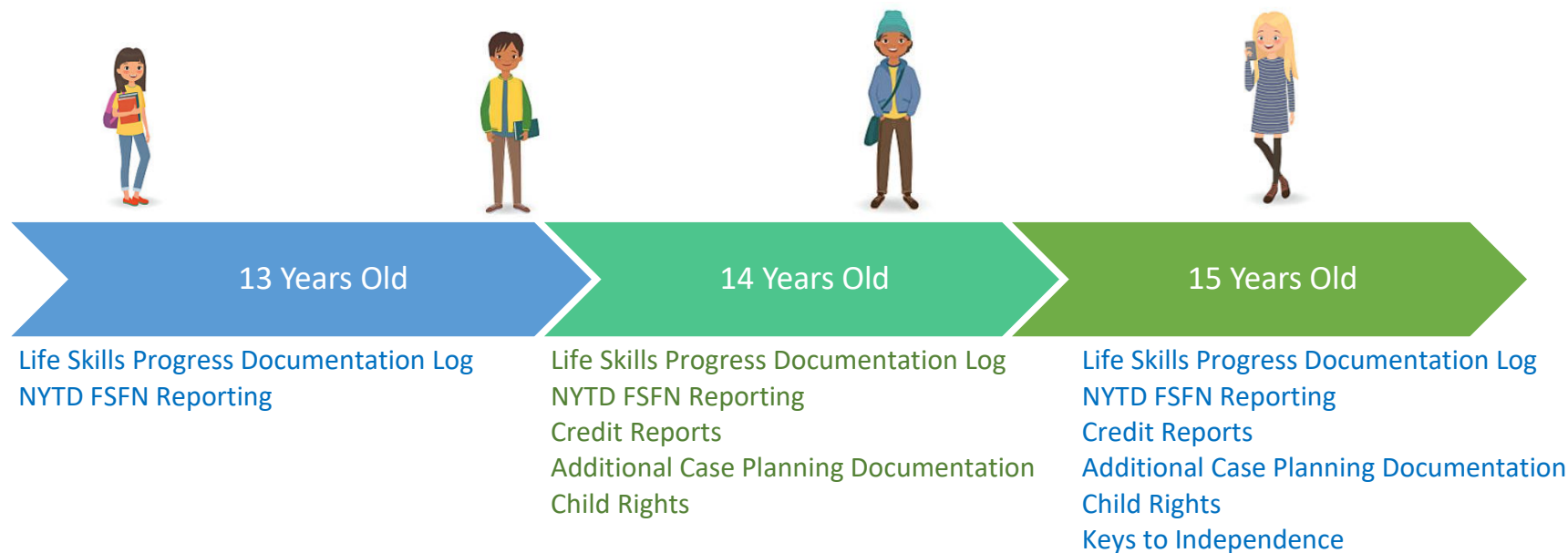
Independent living services is often referred to as transitional services. These types of services encompass a wide range of assistance categories, all geared toward preparing older children for independence. The categories of programs and services to prepare for the transition to a successful adulthood align with the National Youth in Transition Database (NYTD) and include independent living needs assessment, academic support, post-secondary educational support, career preparation, employment programs or vocational training, budget and financial management, housing education and home management training, health education and risk prevention, family support and healthy marriage education, mentoring, and, when young adults are eligible, supervised independent living, room and board financial assistance, education financial assistance, and other financial assistance.

Beginning at age 13, children in out-of-home care require additional support and case coordination to help them develop necessary life skills, achieve permanency, and ultimately transition to a successful adulthood. Most life skills will be developed through normal day to day activities in children's natural living environments.

This job aid was created to assist in visualizing the desired outcome goals, age for expected service delivery, and the policy that drives the practice.



13 to 15-Year-Old Transition Services Requirements



Caregivers are required to take the lead role in ensuring children and young adults in their home are provided the opportunity to develop the skills necessary to transition to adulthood using a reasonable and prudent standard and report the progress of skills development. These skills include daily living activities to prepare them for self-sufficiency.

Child Welfare Professionals support, train, and assist caregivers with their responsibilities. When the caregiver lacks the ability and resources, the Child Welfare Professional must ensure children receive the necessary skills. Child Welfare Professionals must also ensure all additional support and case coordination for this population is documented in Florida Safe Families Network (FSFN).
