EXECUTIVE SUMMARY

This 22nd Annual Sheriffs' Program Performance Evaluation Report complies with section 39.3065(3)(d), Florida Statutes (F.S.), concerning quality performance, outcome-measure attainment, and cost efficiency. This year, a team of peer reviewers from Sheriffs' Offices and the Department of Children and Families (Department) completed a benchmark review of a closed investigation as a component of the annual evaluation.

The seven Sheriffs' Offices conducting child protective investigations (Broward, Hillsborough, Manatee, Pasco, Pinellas, Seminole, and Walton) encompass metropolitan areas where more than a quarter of the state's child population resides. A total of 175,314 child protective investigations were conducted in Florida during Fiscal Year (FY) 2021-2022¹ and the seven counties where Sheriffs' Offices handle investigations conducted 43,039 (24.55 percent) of the state's investigations. The longstanding commitment of the Sheriffs' Offices involved in child protective investigations toward engaging families, protecting children, and working in partnership within their communities remains consistent and strong. They are an essential partner in moving forward with shared the values, principles, and efforts the Department seeks for enhancing Florida's child protection system.

With the implementation of the Quality Office, monitoring instruments have been revised to include Life-of-Case Reviews that occur at key points during open investigations. The review is conducted on open cases to allow for real-time adjustments, if needed, to change the course of an investigation to ensure child safety. The annual peer review uses the same monitoring instrument to complete a benchmark review of an investigation closed during the prior year. The benchmark review works to align the Sheriff's Office with the quality assurance tool and Office of Quality expectations of case handling while also evaluating strengths and opportunities based on the outcomes. The review teams consist of members from each Sheriff's Office and representatives from the Department to increase consistency across each review site.

Section 39.3065(3)(b), F.S., requires Sheriffs' Offices to operate in accordance with performance standards and outcome measures established by the legislature. Child protection and child welfare outcomes are established in section 409.986(2), F.S. Both measures listed below are included in the Sheriffs' grant agreements:

- Percent of investigations commenced within 24 hours: Target 99.5 percent.
 - o Department performance: 99.17 percent.
 - Sheriffs' Office performance: 99.36 percent.
- Percent of victims seen within 24 hours of receiving a report: State target 90 percent, Sheriff Target: 85 percent.
 - Department performance: 91.53percent.
 - Sheriffs' Office performance: 91.93 percent.

SECTION I: SHERIFFS' INVOLVEMENT IN CHILD PROTECTIVE INVESTIGATIONS

Sheriffs' Offices in Broward, Hillsborough, Manatee, Pasco, Pinellas, Seminole, and Walton counties are authorized under section 39.065, F.S., to conduct child protective investigations in their respective counties. Upon receiving a report of known or suspected child abuse, abandonment, or neglect, or a child in need of supervision and care and has no parent, legal custodian, or responsible adult relative immediately known and available to provide supervision and care, the Florida Abuse Hotline accepts five types of child intake reports:

- 1. In-home reports alleging maltreatment by a child's caregiver.
- 2. Institutional reports alleging maltreatment of a child by another person responsible outside of the child's caregiver (i.e., incident at school, childcare facility, etc.).
- 3. Child-on-child referrals alleging inappropriate sexual behavior or an alleged juvenile sexual offense.
- 4. Human Trafficking allegations.
- 5. Special condition referrals that include Parent Unavailable, Parent in Need of Assistance (PNA), and Foster Care Referrals.

The Florida Abuse Hotline is required to refer allegations of criminal conduct to the law enforcement agency of the municipality or county in which the alleged conduct has occurred. These criminal allegations are not considered child protective investigations, and, therefore, are not included in this report.

Child Population

During FY 2021-2022, 28.13 percent of Florida's child population resided in a county where the Sheriff's Office performs child protective investigations. The seven Sheriffs' Offices received 24.55 percent of initial and additional reports and special condition referrals. This totaled 43,039 reports and special condition referrals for the respective Sheriffs' Offices.

Initial and Additional and Special Condition Reports

Of the 175,314 child investigations and special condition reports received in FY 2021-2022, there were 145,281 initial intake reports, 11,384 additional intake reports, and 18,649 special condition intake reports.² There were 49,144 fewer reports in FY 2021-2022 than FY 2020-2021.

² Each Sheriff's Office also handles various requests received from other states and/or other counties for child protective investigative assistance. Most requests include obtaining records, conducting a child-welfare check, verification of information, emergency home studies, etc. The work volume associated with such in-state requests (also known as out-of-town inquiries or OTIs) and inter-state requests varies from county to county but is estimated by the Sheriffs' Offices to account for an average of ten percent of incoming casework assigned to child protective investigators. These requests for assistance are not officially tabulated or captured by the Department as a workload element when capturing active caseloads.

The seven Sheriff's Offices were responsible for 43,039 initial intakes and additional reports and special condition referrals during FY 2021-2022, or 24.55 percent of the statewide total. This is a decrease of 855 reports from FY 2020-2021.

Incoming Reports and Special Conditions by Type by County

The tables on the following pages provide data for each of the seven Sheriffs' Offices for incoming reports by type and special condition referrals by type. The source for the data in the following tables comes from the FSFN report *Child Investigations Received by Intake Sequence Type – Statewide by Agency* and excludes special conditions referrals. The Percent of State's Total Monthly Average is from the table *Percentage of Child Protective Investigations by Sheriff, CBC, and Department FY 2021-2022* on page 2 of this document.

The tables list the statewide percentage of child and special condition reports that the respective county received. The term "initial" refers to in-home and institutional investigations received regarding a child. The term "additional" references new allegations concerning a child that are received during a timeframe in which there is already an open and active initial investigation. "Special condition" referrals include the following:

- Child-on-child sexual abuse.
- Parent seeking assistance.
- Child is without custodial care or supervision as the caregiver/parent is reported unavailable.

Broward Sheriff's Office

Broward Sheriff's Office received 11,044 child investigations and special condition referrals, which averaged 920.33 reports and special condition referrals monthly in FY 2021-2022. Special Condition referrals accounted for 7.92 percent of the intake workload. Broward County had a monthly average of 2.06 intake reports received per 1,000 children residing in the county.

Special Condition referrals accounted for 8.03 percent of the intake workload. Hillsborough County had a monthly average of 2.78 intake reports received per 1,000 children residing in the county.

SECTION II: PEER REVIEW

Section 39.3065 (3)(d), F.S., requires the Sheriff's program performance evaluation be conducted by a team of peer reviewers from the respective Sheriffs' Offices that perform child protective investigations and representatives from the Department. The peer review was completed in the fall of 2022.

Overview

Each Sheriff's Office completed a Life of Case review of an investigation handled by their agency in the past 12 months. The goal of the peer review was to align the Sheriff's Office with the quality assurance tool and Office of Quality expectations of case handling while also evaluating strengths and opportunities based on the outcomes. All seven Sheriff's Offices provided one reviewer from their respective agency to participate. Each panel participant completed a case review. Participants were involved with a panel discussion and an exit review of their findings upon completion of the review. All panel discussions included two Department reviewers and a moderator who were consistent throughout the seven-week review process.

SECTION III: OUTCOME MEASURE ATTAINMENT

Section 39.3065(3)(b), F.S., requires Sheriffs' Offices to operate in accordance with performance standards and outcome measures established by the Florida Legislature protective investigations conducted by the Department. Child protection and child welfare outcomes are established in section 409.986(2), F.S. The General Appropriations Act sets forth appropriations allocated through multi-year grant agreements with the seven Sheriffs' Offices performing child protective investigations. The grant agreements cite two performance measures for the Sheriffs' Offices.

Performance Measure 1: Percent of investigations commenced within 24 hours [Target Goal – 99.5 percent]

The performance measure is based on 65C-29.003(1)(b), F.A.C. which states, *Commencement of the investigation is the first attempt to complete an on-site visit for the purpose of making a face-to-face contact with the child victim of the report within twenty-four hours of acceptance of the report.*

Section 39.201(5), F.S., states, in part: If it appears that immediate safety or well-being of a child is endangered, that the family may flee, or the child will be unavailable for purposes of conducting a child protective investigation, or that the facts otherwise so warrant, the Department shall commence an investigation immediately, regardless of the time of day or night. In all other child abuse, abandonment, or neglect cases, a child protective investigation shall be commenced within 24 hours after receipt of the report.


In FY 2021-2022, there was a total of 177,027 initial and additional reports as well as special condition referrals statewide. Of this number, 145,279 (82.1 percent) were regular initial abuse reports; 13,103 (7.40 percent) were special condition referrals, and 18,645 (10.5 percent) were additional reports. All of these required an initial 24-hour or immediate response with the following exceptions:

- 1. "Parent Needs Assistance" referrals may be handled outside of the customary 24-hour, face-to-face commencement response, as permitted by Department protocol.
- 2. "Foster Care Referrals" (FCR) may be commenced within 48 hours if initial circumstances warrant, as permitted by Department protocol.

Calls received by the Florida Abuse Hotline with supplemental information (with no new/additional victims, alleged perpetrators, or allegations of harm on open investigations) were not referenced or added to the total number of reports received, since supplemental reports do not require an additional commencement or face-to-face visit by the child protective investigator. There were 27,941 supplemental reports added to open investigations in FY 2021-2022, averaging 2,328 supplemental reports accepted monthly.

The measure includes only initial commencements. This data is based on those initial reports that closed each month. If the data reflected a commencement within 24 hours of report acceptance, the commencement would be within compliance.


Performance reports exclude special condition referrals from being included in the data tracking on this measure. The data provided also excludes those report commencements that are associated with an additional report and investigations closed as being a duplicate or no-jurisdiction.

Victims Seen Within 24 Hours

Sheriffs' grant agreements include the performance measure of 85 percent of child victims being seen within 24 hours of the receipt of a report. The Sheriffs' Offices collectively performed at 91.93 percent, the Department at 91.53 percent, with a statewide performance of 91.63 percent. The Department's internal target for this item is 90 percent.

Additional Department Program Performance Measures


Other Performance Measures, although not in the Sheriffs' grant agreements, are important to overall casework practice statewide.

Investigation Closed by the 60th Day

The basis for this performance measure is section 39.301(16), F.S., which states, the Department shall complete its protective investigation within 60 days after receiving the initial report, unless:

- (a) There is also an active, concurrent Criminal investigation that is continuing beyond the 60-day period and the closure of the protective investigation may compromise successful criminal prosecution of the child abuse or neglect case, in which case the closure date shall coincide with the closure date of the Criminal investigation and any resulting legal action.
- (b) In child death cases, the final report of the medical examiner is necessary for the Department to close its investigation and the report has not been received within the 60-day period, in which case the report closure date shall be extended to accommodate the report.
- (c) A child who is necessary to an investigation has been declared missing by the department, a law enforcement agency, or a court, in which case the 60-day period shall be extended until the child has been located or until sufficient information exists to close the investigation, despite the unknown location of the child.


During Fiscal Year 2021-2022, the Sheriffs' Offices collectively performed at 98.37 percent, the Department at 97.92 percent, with a statewide performance of 98.04 percent.

Initial Supervisor Consultation Within 5 Days

During Fiscal Year 2021-2022, the Sheriffs' Offices collectively performed at 95.76 percent, the Department at 97.45 percent, with a statewide performance of 97.03 percent.

SECTION IV: COST EFFICIENCY

This section provides an assessment of the cost efficiency based on the cost for initial and additional reports for the Sheriffs' Offices and Department regions. The table below provides expenditures and costs per report received during FY 2020-2021 and FY 2021-2022. Dividing actual expenditures by the number of reports received determines the cost per report, not using averages.

The cost for Sheriffs' Offices in 2021/2022 ranged from \$1087 to \$1,967 with an overall average cost of report for Sheriffs of \$1,547. The cost for the Department ranged from \$1,055 to \$1,386 with an overall average cost of \$1,291 per investigation. The overall difference in cost between the Sheriffs' Offices and the Department was \$195 per report.
