Psychotropic Medications Report for Children in Out-of-Home Care with One or More Current Prescriptions for a Psychotropic Medication

Statewide by Region by Agency As of 05/28/2024

Purpose:	This report provides information on children in out-of-home care and the number and percent who have a psychotropic medication prescribed.
Criteria:	<p>All children in an active out-of-home care placement as of the report date are included in the report. In addition, children who are an active participant in a case with a service role of child or blank who are in a removal episode that has not yet been discharged but their last placement has been end-dated are also included in the report.</p> <p>A psychotropic medication is any medication selected from the medication drop-down list (excluding "Other") on the FSFN medications screen or if "Other" is selected and the medication is flagged as a Psychotropic Medication or as being used for psychotherpeutic purposes.</p>
Tabs:	<p>The "Ages 0 to 17" tab provides summary counts and percentages of children, ages 0 to 17, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run date.</p> <p>The "Ages 0 to 5" tab provides summary counts and percentages of children, ages 0 to 5, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run date.</p> <p>The "Ages 6 to 12" tab provides summary counts and percentages of children, ages 6 to 12, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run date.</p> <p>The "Ages 13 to 17" tab provides summary counts and percentages of children, ages 13 to 17, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run date.</p> <p>Placement Setting Descriptions: A relative/non-relative placement includes children placed with relatives or approved family friends. Licensed Substitute Care includes children placed in licensed foster care, group homes, and residential treatment facilities. The Other placement setting includes children who are missing (runaway/absconded/abducted), in a hospital, correctional placement, or other placement settings not included above. Children who are in the process of changing placements (i.e., a placement had been ended and new one has not yet been entered into FSFN) or whose placement information has otherwsie not yet been entered into FSFN are counted in the "Placement Data Not Available" columns.</p> <p>The "Meds by Age" tab provides a summary count of children with an active psychotropic medication as of the report run date by each age.</p> <p>Age on each of the above tabs is as of the report run date.</p> <p>The "Consent" tab provides summary count and percentages of children with an active psychotropic medication as of the report run date and the type of consent (parental, court, or none) for each child documented in FSFN. If the child has one or more medications for which consent has not been properly documented, the child is counted in the "No Consent Obtained" counts. If all medications have consent properly documented and one or more is documented as Parental Consent, the child is counted in the Parental Consent counts. If all medications have consent properly documented and all such consents are Court Order Obtained, the child is counted in the Court Order counts. Proper documentation includes either Parental Consent or Court Order Obtained and the date such consent was obtained both being documented in FSFN. Any consent dates that are after the run date of the report or which are entered after the report run date are not considered valid for these pupposes. The Consent tab includes the counts and percentages for all children with a prescribed medication as well as a separate set of counts and percentages for only those children for whom parental rights have been terminated.</p> <p>The "Gender" tab inculdes counts and percentages of children with a prescribed medication as of the report date by gender.</p> <p>The "Race" tab inculdes counts and percentages of children with a prescribed medication as of the report date by race. If a child has only one of either Black/African-American or White selected in FSFN, they are counted in those columns. Otherwise the child is counted in the Other column.</p> <p>All tabs provide the summary broken down by Region, Lead Agency (Circuits served by the Lead Agency), and Statewide.</p>
