. CALL TO ORDER

Jason Reak called to order the SunCoast Regional behavioral health interagency Collaboration at 11:02 a.m. on February 18th, 2025.

II. Welcome and introductions.

III.

Overview of Regional Collaboration Coordinator Position/Role/Objectives/Vision by Jason Reak provided an overview of the RCC role and background into the Commission on Mental Health and Substance Use Disorder January 1st 2024 report that recommended regional collaboratives to strengthen community networks and cross-agency collaboration. House Bill 7021 section 394.90826, Florida Statutes established Behavioral Health Interagency Collaboratives throughout the state in support of the Commission's recommendation in order to address local level challenges and improve the accessibility, availability and quality of behavioral health services.

IV. IMPACT OF REGIONAL BEHAVIORAL HEALTH

Melissa Leslie, provided an overview on the impact of the Regional Behavioral Health Interagency Collaboratives and the importance of sharing and collaborating on Gap Analysis among agencies. Melissa Leslie shared that The Regional Behavioral Health Interagency Collaborative will meet regularly with quarterly meetings and complete an annual report to be presented to the Florida Legislature. The Collaborative contained required members as part of Chapter 394, F.S. as well as appropriations for the Regional Collaboration Coordinator position. These Regional Behavioral Health Interagency Collaboratives "Kick Off" Meetings are occurring throughout the State for the month of February 2025.

V. MANAGING ENTITY NEEDS ASSESSMENT

Lizette Tabares - Vice President of Behavioral Health Services · Central Florida Behavioral Health Network (CFBHN) presented on the Managing Entities needs assessment.

CFBHN provided an overview of information:

CFBHN is required to complete a needs assessment every three years as outlined in the contract with the Department of Children and Families (DCF).

The needs assessment collects data to assess the needs and gaps for adults and children for both mental health and substance use, along with the priorities and goals, and the integration priorities.

The needs assessment helps inform CFBHN, DCF, and other stakeholders of the service needs and gaps, goals to focus on and initiatives to undertake over the next three years.

The information from the assessment will drive the work of the network staff and will be integrated into the CFBHN Strategic Plan, Enhancement Plan, and Community Plans.

Consistent findings include need for flexibility of funding, access to care, affordable/accessible housing.

Jason Reak provided an overview on the 4 key areas.

- 1. Strengthening Community networks and gross agency collaboration.
- 2. Enhancing Crisis Care Continuum.
- 3. Improving Data Collection and Management Processes.

VII. OPEN DISCUSSION

Attendees were asked to provide responses to the below questions.

- 1.Tell us about your organization GAP Analysis process and if it is public facing.
- 2. What other Collaboratives or Workgroups are you attending, and items being addressed.
- 3. What are opportunities for improvement?

Attendees discussed a capacity assessment, not necessarily a needs assessment and looking at the capacity needs with more of a focus on individual perspective rather than a system perspective. Below are key themes facing the SunCoast Region as shared during today's meeting by those that attended:

Housing – Attendees discussed the lack of availability of affordable housing.

Staffing – Attendees discussed current and future staffing shortages and how this is impacting the region.

Tampa General Hospital - Doug Leonardo - Waitlists – Waitlists can be a critical tool in identifying population needs in the region.

Respite – Attendees discussed for youth and adults as we are limited in options for caregivers to have any breaks and this may help sustain placements.

Charlotte Behavioral Healthcare - Vickie Scanlon - Assisted Outpatient treatment and working with the public defender - This is a level of treatment that can assist from transition from the CSU.

Charlotte Behavioral Healthcare - Amy Hood - Placement for elder with Bx. health Dx and housing options – Lack of placement for the elderly.

Flexibility to use funds – Attendees discussed increasing the flexibility of funding, breaking down funding silos.

Early Dx. For 18 y/o for Agency of Persons with Disabilities - For adults to have benefits and supports through APD they must be Dx. with autism, and development delays and other qualified Dx. Before they turn 18 y/o for the Agency of Persons with Disabilities.

Florida Department of Children and Families - Kelly Kelley - Guardians for incompetent adults - Adults with limited capacity needs a guardian to sign off on documents if they qualify (think about elderly and SPMI). At times they are limited to find.

Charlotte Behavioral Healthcare - Amy Hood - Hurricane response and CCP – As health care providers work to navigate their response after a major storm, there are challenges to those efforts in meeting the needs of local constituents along with balancing the recovery response of staff trying to recovery from major storms in their personal lives.

American Addiction - Karen McGinnis- Peer support – Expanding the valuable insights into the behavioral health system to identify areas where current services are lacking and leading to a more comprehensive understanding of gaps in care via the lived experience of the peer specialist. Increased wages in order to keep qualified individuals for better outcomes.

American Addiction - Karen McGinnis - Medicaid billing – Would allow patients to have longer treatment stays as opposed to 30 days which is to soon in order to improve the quality of behavioral health care outcomes, reduce readmissions and leading to significant cost savings due to greater sustained long-term outcomes.

Operation PAR - Jim Miller - Circuit level collaboration – To better identify the needs to then funnel into the regional meeting. Such as I have 4 circuits and therefore 4workgroups to have focus and intentionality.

Melissa Leslie provided next meeting date May 29th, 2025 and that the meeting will be in in person at a more central location for greater convenience of attendees. Asta Trinh discussed future quarterly Collaborative Meetings to include Agency specific presentations. Survey development to gather information on potential presenters.
