The report is looking for a specific population that meets the following criteria:


1. The child needs to have a placement (Family Support Page, Living Arrangement or Out of Home Placement).
2. The child needs to have a Case Plan or Family Support Plan Worksheet that is active within the reporting period.
3. On the Case Plan Worksheet or Family Support Worksheet, the child needs to have an outcome entered, with a Provider, Service Category as Prevention Services, and a Sub-Service Category.
