MEETING MINUTES

I. CALL TO ORDER

Idris Gaines called to order the Northeast Region Behavioral Health Interagency Collaboration meeting at 11:00 am on August 6, 2025.

II. WELCOME

Idris Gaines, Northeast Regional (NER) Operations Manager for Substance Abuse and Mental Health (SAMH) at the Department of Children and Families (DCF), welcomed attendees and initiated introductions.

Harlee James, Regional Collaboration Coordinator, DCF Substance Abuse and Mental Health (SAMH) Program

Leeanne Sacino, Executive Director of the Florida Coalition to End Homelessness, attending as a representative and presenter

III. PRESENTATION - FLORIDA COALITION TO END HOMELESSNESS

Leeanne Sacino provided an overview of the Florida Coalition to End Homelessness's mission and key initiatives, emphasizing their commitment to "Everyone Working Together to End Homelessness."

- b) Homeless Continuums of Care
- c) Homeless Crisis Response System

Nancy Eisele, from LSF, reported that some housing providers are opting out of Continuum of Care (CoC) networks to maintain direct relationships with landlords, which facilitates faster client housing. She noted that the most significant housing barriers are for vulnerable populations, including those with criminal histories or no income. Eisele asked if the state is funding alternative models like Operation New Hope, which combines housing with employment training. She also inquired about the flexibility of current federal funding to support such initiatives

Leanne responded that the Coordinated Entry System (CES) aims to connect individuals to housing quickly and fairly, prioritizing those with the greatest need. She acknowledged the trend Nancy described is happening statewide and that CoCs are working to better engage providers. Leanne added that while the future of federal funding is uncertain, alternative models, such as Master Leasing, are being explored to increase housing access and improve system responsiveness.

IV. SUCCESS STORIES

Idris Gaines shared success stories from the Northeast Region, highlighting outcomes from the Mental Health Resource Center and FreshMinistries.

- a) A success story was shared about David, a client served by the Mental Health Resource Center.
- b) A client success story from FreshMinistries was also presented.

V. OPEN DISCUSSION

Idris Gaines covered the focus topic of strengthening community networks and cross-agency collaboration.

- a) If we had to prioritize one outcome, what would it be?
- b) Where are we seeing the strongest examples of cross-agency collaboration right now and what made that work?
- c) Where do we see gaps in collaboration between agencies, and what's getting in the way?
- d) What specific strategies can agencies implement together to strengthen partnerships and create a more integrated support network?

Sabrina Howland from the Bradford County School District shared that identifying service gaps remains difficult and that both locating resources and raising awareness continue to be challenges in her role.

Deborah Richmond from Eckerd Connects E-Nini-Hassee, noted challenges in filling staffing vacancies and expressed that a centralized, formal list of providers would be a valuable tool for improving access and coordination.

Erin McVicker from Wolfson's Children's Hospital supported the idea of a provider list, stating it would assist in making appropriate referrals for children transitioning from crisis stabilization to community-based services.

Idris Gaines highlighted the Access to Care Line provided by Lutheran Services Florida (LSF). Dr. Cauffield shared the contact number for the line: 1-877-229-9798.

Debbie O'Neil from MHRC noted that the COVID-19 pandemic disrupted relationship-building efforts between providers. In response, MHRC launched a partnership series with other agencies, facilitating discussions on past collaborations and forming inter-agency task groups to establish shared goals.

David Perry, representing Community Partnership with Children, stated that Autism is a significant barrier to service access for children. He noted that because Autism is classified as a medical, not a mental health condition, it often leads to insurance denials. He asked if any efforts are underway to address this issue and improve service access for children with Autism.

Idris noted that the team will follow up with AHCA for further clarification regarding David's question.

VI. FUTURE COLLABORATIVES

Idris Gaines presented information on the future of the collaborative to include:

- a) Attendance Metrics
- b) Survey outcomes- statewide priorities, regional priorities, need for additional resources and supports.
- c) Lunch and learns previous presenter and schedule of future meetings.
