I. CALL TO ORDER

Diveka Anderson, Regional Collaboration Coordinator, called to order the Regional Behavioral Health Interagency Quarterly Meeting at 10:00 A.M. on Friday, August 8th, 2025.

II. WELCOME AND INTRODUCTIONS

Morgan Schell, Regional Operations Manager, welcomed attendees and introduced the following:

Leeanne Sacino, Executive Director from the Florida Coalition to End Homelessness, who would also be presenting at the meeting.

Housekeeping reminders were provided regarding microphone muting, Q&A procedures, and the use of the chat feature.

III. PRESENTATION – FLORIDA COALITION TO END HOMELESSNESS

A PowerPoint was shared by Leeanne Sacino, Executive Director of the Florida Coalition to End Homelessness, providing an overview of the Homeless Response System and the role of Homeless Continuums of Care (CoCs). Key points included:

- CoCs are local/regional planning bodies that coordinate services, set priorities, and apply for funding.
- Responsibilities include annual Point-in-Time counts, coordinated entry systems, capacity building, and monitoring outcomes.
- CoCs operate with open membership, encouraging broad community participation.
- The Coordinated Entry System prioritizes individuals least likely to self-resolve, ensuring intensive services for those most in need.
- Collaboration emphasized through peer-to-peer problem-solving, trend analysis, and state/federal advocacy.
- Attendees were encouraged to join CoC networks to share resources, contribute to data collection, and strengthen access.
- Importance of client and peer education, advocacy, and leveraging shared data to close service gaps and improve outcomes statewide.

After presentation concluded, Question and Answer portion of the presentation began, microphones were unmuted, and open discussion with Ms. Sacino discussed the following:

Officer Elijah Shabazz, Belle Isle Police Department, raised concerns about housing resources for families with autistic children living in transient housing, and challenges for those with language barriers. He asked if there was there anything he could do to get them services or some type of permanent housing?

Leeanne Sacino, Florida Coalition to End Homelessness, advised exploring Rapid Rehousing (up to 2 years rental assistance with supportive services) and contacting the Homeless Services Network of Central Florida for translation resources.

Dr. Mery Lossada, Empath Health, Hospice of Marion County (HMC), addressed the increasing amount of homelessness among seniors with cognitive decline and chronic illness; lack of legal representation for benefits access. She asked if there was a way to measure and develop a plan to expedite the process due to not having a POA (power of attorney)?

Leeanne Sacino Florida Coalition to End Homelessness, discussed the SOAR program for expedited benefits applications and noted statewide initiatives targeting elderly and chronically ill homeless individuals.

IV. PROVIDER SUCCESS STORIES

Diveka Anderson highlighted stories from the following Network Service Providers:

- Space Coast Health Centers Single mother of six stabilized health, avoided eviction, and returned to work.
- Aspire Health Partners (Insight Program) First-episode psychosis client achieved one-year sobriety and reconnected socially.
- Tri-County Human Services Former amphetamine user transitioned from homelessness to full-time employment.
- LifeStream (Anthony House) Mother overcame opioid addiction and reunified with her child.

V. FOCUS TOPIC AND OPEN DISCUSSION

Diveka Anderson led the open discussion portion of the meeting and discussed questions with the focus topic: Strengthening Community Networks & Cross-Agency Collaboration.

Question 1:

How can this collaboration assist with bridging the gaps with providers and agencies?

• Dr. Mery Lossada, Empath Health, (HMC), suggested creating a centralized statewide resource site with clear service descriptions.

Question 2:

What existing partnerships have been the most impactful in supporting behavioral health outcomes in our region?

 Tracy Grey, Heartland for Children, Inc., discussed robust partnerships with child welfare agencies and Polk County Public Schools through leadership meetings and a collaborative council.

Question 3:

What strategies can agencies implement together to strengthen partnerships?

- Tracy Grey, Heartland for Children, Inc., emphasized identifying points of contact and setting intentional goals for collaboration.
- Brianna Kelley, Marion Senior Services, recommended high-utilizer case review meetings to assess strengths, weaknesses, and streamline services.

Question 4:

If you could enhance one aspect of cross-agency collaboration, what would it be?

- Dr. Mery Lossada, Empath Health, (HMC), suggested improving communication and sharing real-time service capacity updates.
- DJ Ryan, Marion Senior Services, noted "communication and data" as priority needs in the chat.

Diveka Anderson concluded the discussion by thanking attendees for their participation and engagement.
