INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth and young adult tobacco access laws (FFY 2025 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth and young adult tobacco access rates (FFY 2026 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth and young adult tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth and young adult tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance

with youth and young adult tobacco access laws.

Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2025 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2026 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–8 (in Excel) to WebBGAS. Please note that, in the FFY 2026 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel), as well as a database with the raw inspection data to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- Synar Inspection Protocol: States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections. This document should be different than the Appendix C attached to the Annual Synar Report.
- A scanned copy of the signed Funding Agreements/Certifications

Synar surveys are generated randomly by a computer program. Given the marginal percentage of licensed tobacco premises in the state being surveyed (one percent),

most of the locations being surveyed are remote. If at any time, the manager of the site being surveyed alerted other locations, typically, only other sites in that chain would be notified. The managers would more than likely not notify their competition.

At the local level, ABT works with community anti-drug coalitions by being a member of the coalition and collaborating across education and enforcement activities. ABT conducted <u>4,591</u> additional tobacco surveys during the Synar period of October 1, 2024 – September 22, 2025. Of these <u>332</u> were in response to complaints and <u>4,259</u> were initiated randomly for proactive underage sales enforcement.

Florida plans to maintain the target rate for Synar inspections to be completed in FFY 2026. The State does not intend to change any methods employed to carry out the Synar inspections, which include: the random sampling procedures; inspection procedures; regulations or policies; and vendor education activities.

The state will make every effort to maintain its current low rate of retailer violations and will continue the following activities: post signs at all tobacco outlets (English and Spanish) as required by state statute and require all sales personnel to check identification for all purchasers of tobacco products who appear to be under 30 years of age.

The Division of Alcoholic Beverages and Tobacco, working with local law enforcement, local tobacco coalitions, and school groups will continue to recruit Investigative Aides (IAs) under the age of 18 to participate in these inspections. Young adult investigative aides (ages 18-19) are recruited through brochures, flyers, etc. and are not required to be enrolled in college. All investigative aide's appearance will match their age, and their parents are required to approve their participation if under the age of 18. They also must not have a criminal record unless they are under court order to assist law enforcement.

IAs will be trained in inspection procedures prior to their participation. Two state agents will accompany each investigative aide. One agent will position themselves where they can observe the IA inside the outlet and the IAs attempt to purchase tobacco products. The other agent will position themselves in a support position. If a purchase is made, the clerk will normally be arrested and issued a Notice to Appear (if the clerk meets the criteria for this issuance) for a violation of Florida Statute 569.101 (misdemeanor).

The state will continue to use the approved survey sampling strategy: A list of all active and delinquent (non-renewed, but active within the past 60 days) licensed tobacco outlets will be compiled by county. Florida will use the approved sample size formulas listed in Question #9 of Appendix B to calculate the required original sample size for the Synar survey. In

addition, Florida will further inflate the original sample size to include additional outlets equal to the number of ineligible outlets and eligible non-complete inspections from the state's most recently approved ASR as of September 1st of each year.

This is the type of sampling method Florida has utilized in previous coverage studies completed. Florida has a total of 5,160 census tracts with over 31,000 tobacco outlets. For this project, CCA included twenty-five (25) census tracts, yielding an estimated sample of 175 - 225 outlets. *One tract yielded 0 establishments, so CCA included an additional tract to ensure establishments were found in 25 tracts. To account for differences in urban and rural census tracts, CCA sorted the sample by population density and numbered each tract from 1-5,160.
