#### I. CALL TO ORDER

Harlee James called to order the Northeast Region Behavioral Health Interagency Collaboration meeting at 11:00 AM

### II. WELCOME

Harlee James welcomed the attendees, introduced the DCF SAMH staff and Dr. Cauffield

## III. PRESENTATION – LUTHERN SERVICES FLORIDA HEALTH SYSTEMS

Strategic Priorities

Dr. Cauffield concluded her presentation with contact information for herself and Shelley Katz, LSFHS Chief Operating Officer.

### **Question and Answer:**

Karen Chrapek from Volusia Recovery Alliance asked for insights and next steps regarding the exemption process and the workforce barriers it creates.

Response: Dr. Cauffield explained to the group that Peer Specialists must complete
a level 2 background screening when entering the workforce and if they have prior
legal charges, this acts as a barrier. She noted that Senator Darryl Rouson has
passed legislation to ease some of these requirements while acknowledging that
additional progress is needed. She recommended continued engagement with
Senator Rouson on this initiative.

Deborah Sibley from Kids Hope Alliance asked if the Needs Assessment would be available after the meeting.

 Response: Harlee James confirmed that the presentations would be sent to attendees following the meeting.

Dr. Courtney Whitt introduced herself as the Executive Director of the Florida Center for Behavioral Health Workforce, which works to address regional workforce needs identified in the Needs Assessment. She emphasized that the Center is needs driven and community grounded and welcomed continued feedback from partners. She described an interactive dashboard on the Center's website that provides data on the current behavioral health workforce and noted that the dashboard is currently being expanded. She explained that this resource can support progress tracking, grant development, and legislative discussions. Dr. Whitt also announced a December forum focused on psychiatric mental health nurse practitioners and she shared her contact information in the chat.

## IV. IMPACTFUL MOMENTS

Harlee James shared impactful moments from the Northeast Region.

 An Impactful moment from Child Guidance Center highlighted the wide range of services offered at the agency along with the growth of its Mobile Response Team made possible through support from LSF Health Systems.

 An Impactful moment from Gateway Community Services highlighted the expansion of its recovery services made possible through strong support from LSF Health Systems.

## V. NEXT STEPS AND 2026 VISION

Idris Gaines provided an overview of the 2025 Northeast Regional Behavioral Health Interagency Collaboration events. He reviewed:

- Quarterly Meetings
- Participant Attendance
- Positive Collaboration
- Stakeholder Feedback

Idris also discussed next steps and the 2026 vision, which include:

- The continuation of the Statewide Lunch and Learn series. Highlighting that the next Lunch and Learn will be held on December 11, 2025, with Coordinated Opioid Recovery presenting.
- Upcoming Quarterly Regional Behavioral Health Interagency Collaboration Meetings. Sharing that the next meeting will take place on January 15, 2026, at the Alachua County Public Library Tower Road Branch in a hybrid format. The address for the Alachua County Public Library is 3020 SW 75th St, Gainesville, FL 32608.
- The need for impactful speakers in future meetings and a request for feedback on topics and presentations.
- The development of outcome driven workgroups focused on critical needs identified in survey data.

## VI. PUBLIC COMMENT

Shannon Robinson spoke about her family's experience seeking support for her son's behavioral health needs. She shared that although the situation began one year ago, her family continues to face difficulty accessing appropriate services. She asked whether additional resources might be available in the future for families who experience complex behavioral health crises within the home. In response to a question about her location from Dr. Cauffield, Shannon described the challenge of securing the specific services her son required due to the absence of initial legal involvement. She explained that once the legal system became involved, she encountered significant obstacles related to insurance costs plus the need to demonstrate medical necessity for a residential program. She noted that

the CBC provided assistance with program expenses. Shannon concluded by expressing that many families in the community face similar barriers when they attempt to locate appropriate services or navigate insurance requirements.

Idris Gaines acknowledged Dr. Cauffield's raised hand and invited her to address
the question. Idris also asked whether any additional providers on the call could offer
support. Dr. Cauffield shared that LSFHS serves individuals who are uninsured or
underinsured, and that through the LSFHS network of care, funding is provided to
support access to services. Dr. Cauffield introduced child specialist, Erica Machnic,
provided her contact information in the chat so that Shannon could connect with her
regarding next steps.

Dan Renaud with New Hope Addiction and Education Services, Inc. reported that overdose rates among BIPOC youth and adolescents are rising, and that substance use is occurring at younger ages. He noted that services for adolescents and preadolescent youth remain underfunded, which significantly affects educational outcomes, increases the risk of unintended pregnancies, and heightens vulnerability to human trafficking. He asked whether there would be an opportunity to begin addressing this issue more aggressively.

A question was read from Erin McVicker with Wolfson Children's Hospital, who asked whether there were available mentor programs in St. Johns County for teens who have aged out of foster care or were adopted through DCF, and who are now experiencing homelessness while pursuing college or entering the workforce.

- Response: Harlee James shared with Erin, that she would send her resources in that area for mentorship programs after the meeting.
- Response: **Hope Walton** from Flagler OARS added that she has had positive experiences using Port in the Storm, which is a Homeless Youth Center.
- Response: Dr. Cauffield shared the 24/7 LSF Health Systems Access to Care Line, which can provide information on available resources. She placed the contact information in the chat and shared it verbally during the meeting.

Gregory Stewart from UF Health Psychiatric Hospital shared that he previously participated in an interagency collaboration that created a community resource guide outlining available services. He suggested this as a helpful idea for a future subgroup.

• Response: **Idris Gaines** invited Gregory Stewart to contribute his experience to one of the subgroups as they are developed.
