SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

FEI and Managing Entities require the ability to enable/disable validation rules based on a configurable comparison date from within the FASAMS UI.

Scope Definition

FEI will update the Business Rules Workspace to include parameters for Effective Date and Expiration Date based on a data set comparison date.

FEI will also update the Rule Collection Window to display the new parameters as columns. Note: Fields will not be editable from the Rule Collection Window.

Finally, FEI will update the Rules export document to include the new parameters as columns.

Assumptions, Constraints, Dependencies

This enhancement applies only to FASAMS Version 14.

Note: Fields will not be editable from the Rule Collection Window.

EXISTING FUNCTIONALITY

Currently users are not able to configure validation rules based on a comparison date within the FASAMS UI.

PROPOSED FUNCTIONALITY

Within the Business Rule Workspace, users with the Edit Business Rules permission will be able to configure the effective and expiration date of validation rules based on a data set and comparison date (provided as dropdown menus).

Users with access to the Rule Collection Window will see the four new parameters displayed as columns: Data Set, Comparison Date, Effective Date, and Expiration Date.

Users with access to export the Rules will see the new parameters displayed as columns in the Excel export document.

REQUIREMENTS

FEI will update the Business Rules Workspace to include parameters for Effective Date and Expiration Date based on a data set comparison date.

Note: The Data Set dropdown will include a list populated with only the current data set or “upstream” (parent) data sets for the selected rule collection.

The Comparison Date dropdown will include a list populated with date fields from the selected data set plus SubmissionDate.

FEI will also update the Rule Collection Window and Rules export document to include the new parameters as columns.
