

Finalized Enhancements

1. Add FEIN to Error Reports (WI 538070)

- DCF requests that the Federal Tax Identifier (FEIN) be added to the Job Error Report and Job Error UI for the dataset types Waiting List Version 14 and Subcontract Version 14. This enhancement is in response to a field request for additional information in the Job Error Report.
- FEI will add a column for Federal Tax Identifier to the Job Error Report and Job Error UI for Waiting List Version 14 and Subcontract Version 14.
 - 1.0 Update the Job Error Report and Job Error UI for dataset WaitingListVersion14 with a new column
 - 1.1 Add a new column to the Job Error Report.
 - Column name: FederalTaxIdentifier
 - Populate from ProviderModule.Provider.FederalTaxIdentifier
 - Add to both versions of the Job Error report:
 - Excel report
 - Placement: Column H, ahead of Type column
 - PDF report
 - Placement: fourth column, ahead of ErrorType column
 - 1.2 Add a new column to the Job Error UI.
 - Column name: FederalTaxIdentifier
 - Populate from ProviderModule.Provider.FederalTaxIdentifier
 - Placement: fourth column, ahead of ErrorType column

2. Allow Historical ScoreNumber (WI 542739)

- DCF requires that FASAMS no longer accept Evaluation ScoreNumber for ToolCodes 5, 6, and 8. Managing Entities require the ability to continue to submit ScoreNumber for ToolCodes 5, 6, and 8 for historical evaluations if the EvaluationDate is prior to 7/1/2022.
 - FEI will update an existing business rule to allow the submission of Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is prior to 7/1/2022.
 - FEI will create a new business rule to prevent the submission of Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is on or after 7/1/2022.
 - 1.0 Update business rule “Score Number Required if Vocabulary Has a Range Rule”
 - Make ScoreNumber optional for ToolCodes 5, 6, and 8 when EvaluationDate is prior to 7/1/2022
 - 2.0 Create new business rule:
 - Rule name: “Score Number must not be provided if Tool is 5,6,8”
 - Add a parameter to create a reference date after 7/1/2022 so the rule is only effective on or after 7/1/2022
 - Description: ScoreNumber for ToolCode 5, 6, or 8 with EvaluationDate on or after 7/1/2022 should be prevented from submission and generate a system error
 - Error message:
 - “Must be a valid ScoreNumber for the Evaluation ToolCode submitted. Valid values are listed in the Evaluation section in Appendix 1 Data Code Values of Pamphlet 155-2.
 - “Root Cause: Invalid ScoreNumber for ToolCode submitted in file.”

3. Add Exclusion Rules for DischargeReasonCode (WI 543619)

- DCF requests that Performance Outcome Measures (POMs) not be required when DischargeReasonCodes 3 or 6 are submitted on a Discharge record. DischargeReasonCodes 3 and 6 respectively represent “Did not complete treatment – involuntary” and “Death”; therefore, DCF and SAMH do not expect or require POMs data in these circumstances.
- Note: There is no requirement to submit a diagnosis or evaluation with Discharge currently in FASAMS.
- The TEDS extract code must be updated to include Discharges submitted without an associated POM.
- FEI will allow the omission of a POM for DischargeReasonCodes 3 and 6 by updating the current rule, “Discharge Must Have Single Outcome Measure Rule.”
 - 1.0 Update the business rule “Discharge Must Have Single Outcome Measure Rule” to exclude the POM requirement when DischargeReasonCodes 3 or 6 are used on the Discharge record.

- 1.0.1 Update the business rule name as follows:
 - Current rule name: “Discharge Must Have Single Outcome Measure Rule”
 - Updated rule name: “Discharge Must Have Single Outcome Measure Rule unless DischargeReasonCode is 3 or 6”
- 2.0 Update the TEDS extract code as follows:
 - When a Discharge is submitted without an associated POM, use the record with the latest PerformanceOutcomeMeasureDate (submitted under Admission)
 - Note: This change will apply throughout to any Discharge submitted without a POM (not only when DischargeReasonCodes 3 or 6 is present)

4. Only Validate New POM Records (WI 550317)

- DCF requests that FASAMS apply business validation rules against only “new” Performance Outcome Measure (POM) records (i.e., not previously submitted to the system).
- FEI will update FASAMS to apply business validation rules against only new POM records (i.e., not previously submitted to the system).
 - 1.0 Update system so that only new (not previously submitted) POM records are processed by the business validation rules.
 - All resubmitted POM records are not revalidated against business rules
 - 1.0.1 The following validation rules from TreatmentEpisodeVersion14DataSet, Performance Outcome Measure Rule Collection are impacted by this change.
 - If record action <> Created, then do not apply the following rules to the record
 1. Performance Outcome Measure Date No Earlier Than Admission Date If Applicable Rule
 2. Performance Outcome Measure Date No Later Than Discharge Date If Applicable Rule
