SCOPE

INITIAL REQUEST & ASSUMPTIONS

Business Statement

DCF requires that FASAMS no longer accept Evaluation ScoreNumber for ToolCodes 5, 6, and 8. Managing Entities require the ability to continue to submit ScoreNumber for ToolCodes 5, 6, and 8 for historical evaluations if the EvaluationDate is prior to 7/1/2022.

Scope Definition

FEI will update an existing business rule to allow the submission of Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is prior to 7/1/2022.

FEI will create a new business rule to prevent the submission of Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is on or after 7/1/2022.

Assumptions, Constraints, Dependencies

This change only applies to FASAMS Version 14.

EXISTING FUNCTIONALITY

Currently users are required to submit an Evaluation ScoreNumber for all ToolCodes per business rule “Score Number Required if Vocabulary Has Range Rule.”

PROPOSED FUNCTIONALITY

Users will be allowed to submit an Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is prior to 7/1/2022

Users will be prevented from submitting an Evaluation ScoreNumber for ToolCodes 5, 6, and 8 if EvaluationDate is on or after 7/1/2022. If a ScoreNumber is submitted for ToolCodes 5, 6, and 8 with EvaluationDate on or after 7/1/2022, the system will generate an error.
