## SCOPE

### INITIAL REQUEST & ASSUMPTIONS

#### *Business Statement*

DCF requests that Performance Outcome Measures (POMs) not be required when DischargeReasonCodes 3 or 6 are submitted on a Discharge record. DischargeReasonCodes 3 and 6 respectively represent “Did not complete treatment – involuntary” and “Death”; therefore, DCF and SAMH do not expect or require POMs data in these circumstances.

Note: There is no requirement to submit a diagnosis or evaluation with Discharge currently in FASAMS.

The TEDS extract code must be updated to include Discharges submitted without an associated POM.

#### *Scope Definition*

FEI will allow the omission of a POM for DischargeReasonCodes 3 and 6 by updating the current rule, “Discharge Must Have Single Outcome Measure Rule.”

FEI will update the TEDS extract code to include Discharges submitted without an associated POM by using the record with the latest PerformanceOutcomeMeasureDate (submitted under Admission).

### *Assumptions, Constraints, Dependencies*

This change only applies to FASAMS Version 14.

### EXISTING FUNCTIONALITY

Users are currently required to submit a POM for every Discharge regardless of DischargeReasonCode.

The TEDS extract requires a POM associated to the Discharge record.

### PROPOSED FUNCTIONALITY

Users will no longer be required to submit a POM for Discharge records if DischargeReasonCode is 3 or 6.

The TEDS extract will include Discharges submitted without an associated POM by using the record with the latest PerformanceOutcomeMeasureDate (submitted under Admission).
