## SCOPE

### INITIAL REQUEST & ASSUMPTIONS

#### *Business Statement*

DCF and the managing entities have determined that the subcontract data set, and its associated rules, create a burden for submitting Service Events into FASAMS. To resolve this, DCF wants all dependencies on the Subcontract to be removed via configuration and thoroughly tested by FEI.

#### *Scope Definition*

FEI will identify all rules associated to the Subcontract, write a script to automatically disabled those rules at deployment, and fully test the system to confirm Service Events have no submission barrier due to Subcontract rules.

#### *Assumptions, Constraints, Dependencies*

Emailed questions:

1. the change identified in section 2.0.1 will not require submitting entities to modify the way they report data
  - a. **Confirmed. Submitting entities will not be required to change the way they submit data**

2. No changes will be required to any of the XML file formats or reported data elements
  - a. **Confirmed. Submitting entities should not change their XML file submissions**
3. No changes will be required to any existing reports
  - a. **Confirmed. No reports are impacted by this change**
4. No changes will be required to ETL processes
  - a. **Incorrect. The ETL process for matching non-client Service Events will be updated to use the FEIN instead of SubcontractNumber (section 3.0)**
    - i. **FEIN is submitted in Service Event so there is no change from the submitting entities' perspective.**
    - ii. **This allows matching (aka de-duplicating) to continue without an issue**
5. No change will be required to the reporting database
  - a. **Confirmed. The Reporting Database structure will not need any change based on this enhancement**

## EXISTING FUNCTIONALITY

Currently, there is array of rules that require users to have correct Subcontract data submitted prior to being able to submit other data sets into FASAMS.

## PROPOSED FUNCTIONALITY

Records will no longer be rejected due to rules associated with the Subcontract data set.
