### BACKGROUND INFORMATION:

In accordance with subsection 415.111(5)(a), Florida Statutes, the Department of Children and Families, Adult Protective Services, is required to annually report to the Legislature the number of false reports of adult abuse, neglect or exploitation referred to law enforcement.

Even though this exercise falls under "Legislative Mandated Reports", the content is so narrow, the letters to the Legislature meet the statutory requirement for notification of the number of false reports referred to law enforcement in the fiscal year 2014-2015.

#### ACTION REQUIRED:

The letters to the Legislature require the Secretary's approval and signature.
