- 1) For Florida State Hospital's Average Cost Per Bed Figure, costs associated with service provision to the Mentally Retarded Defendant Program and the Indigent Drug Program are included.
- 2) SFETC and SFSH's Average Cost Per Bed does not include a 20 year bond payment.
- 3) The general revenue budget for WFCCC is \$5,823,880, which results in an annual state rate of \$72,799 per year and a daily state rate of \$199. However, WFCCC reported a total of \$7,580,048 for their Fiscal Year 2012-13 projected budget, as funds associated with billing Medicare Parts A, B, and D, as well as Institutional Medicaid and Medicaid Crossover are received and incorporated into their total budget. Based on a total budget of \$7,580,048, the annual total cost per bed is \$94,751, and the actual average cost is \$260 per bed day.

Results by facility are rank ordered for each performance measure. The relative ranking for each measure is then multiplied against the performance measure weight. The result is then added to all other ranks per facility to arrive at a total score. Lower total scores reflects better overall performance.
