INITIAL REQUEST & ASSUMPTIONS

Business Statement

DCF requests that the Federal Tax Identifier (FEIN) be added to the Job Error Report and Job Error UI for the dataset types Waiting List Version 14 and Subcontract Version 14.

This enhancement is in response to a field request for additional information in the Job Error Report.

Scope Definition

FEI will add a column for Federal Tax Identifier to the Job Error Report and Job Error UI for Waiting List Version 14 and Subcontract Version 14.

Assumptions, Constraints, Dependencies

This enhancement applies only to FASAMS Version 14.

EXISTING FUNCTIONALITY

Currently, the Job Error Report and Job Error UI do not include the Federal Tax Identifier for datasets Subcontract Version 14 and Waitlist Version 14.

The Job Error Report for Subcontract Version 14 contains the following ten (10) columns.

- Key
- JobName
- JobStepName
- Source
- RootSource
- SourceRecordIdentifier
- Type
- ErrorType
- MessageNumber
- Message

The Job Error Report for Waitlist Version 14 contains all the columns listed above plus the following, totaling eleven (11) columns.

- ProviderSourceRecordIdentifier

The Job Error UI for Subcontract Version 14 contains the following five (5) columns.

- Source
- SourceRecordIdentifier
- Type
- MessageNumber
- Message

The Job Error UI for Waitlist Version 14 contains all the columns listed above plus the following, totaling six (6) columns.

- ProviderSourceRecordIdentifier

PROPOSED FUNCTIONALITY

Users with the ability to see the Job Error Report and Job Error UI for dataset types Waiting List Version 14 and Subcontract Version 14 will now see a column for Federal Tax Identifier.

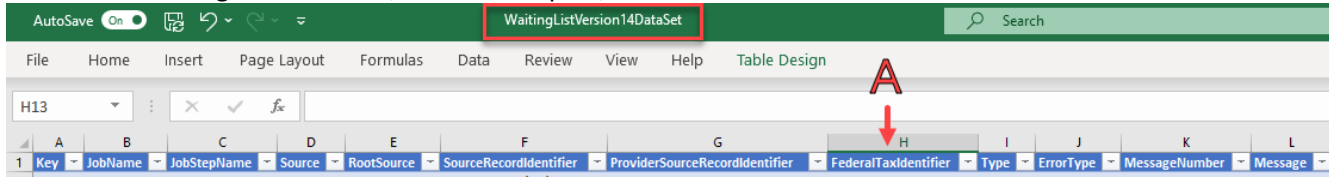

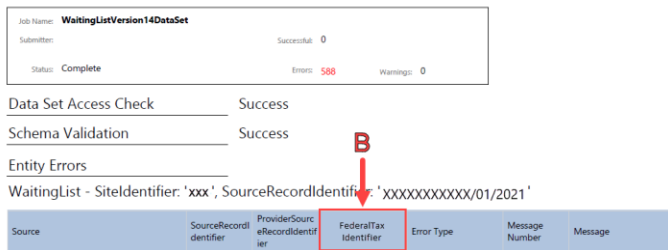

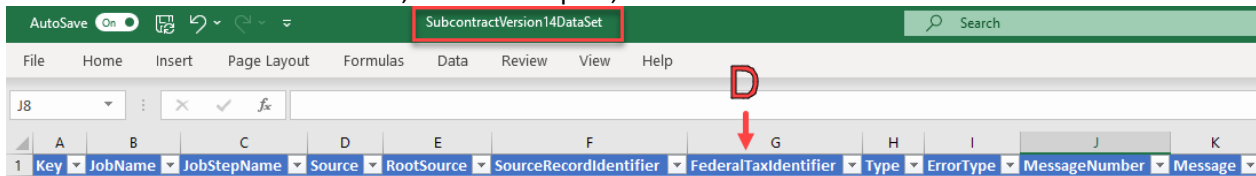

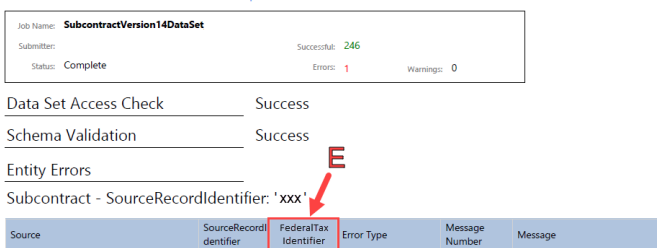

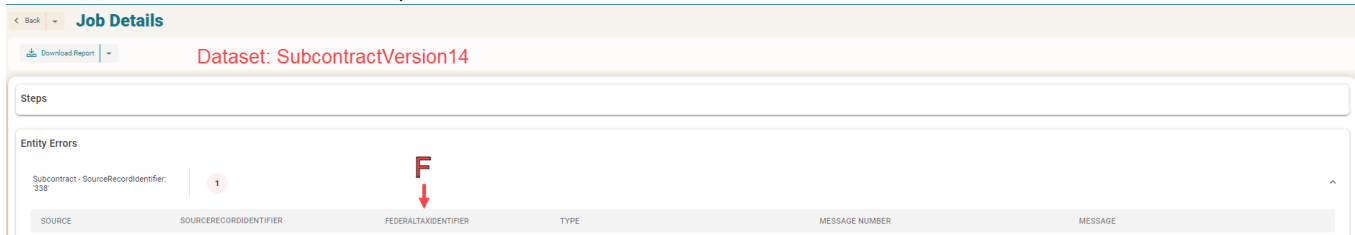
