## 1. Activities Completed During the Week Ending 7/12/019

- The work plans for four Q1 Enhancements have been approved.
- Release 1.2.0 was successfully deployed to UAT.
- Additional work was completed by the SAMH team to grant MEs access to FASAMS data via SSRS.

## 2. Activities Planned for the Week Ending 7/19/2019

- DCF will be reviewing enhancements for Release 1.3.0.
- SAMH will evaluate the analysis and recommendations delivered on 7/28/2019 pertaining to the SANDR, TANF, and DOC Referral Systems – to include three implementation options for each application.
- DCF will continue to work on a solution to grant MEs access to the data they've submitted into FASAMS.
- DCF and FEI will complete additional JAD sessions for Q1 FY2019- 2020 enhancements.
- DCF and FEI will work on implementing changes to data submission rules.

## 3. Upcoming Changes and Noteworthy Details

- The team has designed a solution that satisfies the business requirement to grant MEs access to all the data they've submitted into FASAMS. This solution is scheduled to be completed by September. However, to make data accessible earlier; the team is testing an interim solution that should enable MEs to extract their data via SSRS.
- The SAMH Data Advisory Committee will meet on 7/17/2019.
